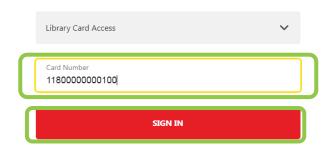

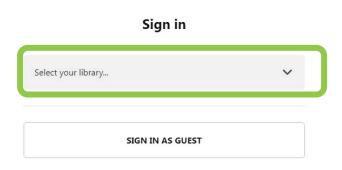

# Accessing LexisNexis Digital – at an LA Law Library location using public computers

### **Guest Access**

- 1. Log on to a public computer.
- 2. Click Legal Research Databases
- 3. Choose **LexisNexis Digital Library** icon
- 4. Click Sign in a Guest



### What's the difference between Guest and Library Card Access?

### Guest Access – Available onsite at LA Law Library

- Browse any LexisNexis Digital title regardless if it is checked out or viewed by another patron.
- Keep your place even if you close the browser.
- Erase your place, notes and history if you log out of LexisNexis Digital or if your computer session ends.
  - o Search session disappears if you log off LA Law Library computer.

### **Library Card Access**

- Session is unique to your library account.
- Save your Search History, Notes and Annotations.
- Maintain a list of the eBooks you have viewed/checked out.
- Place holds.
- Return eBooks and check out others.
- Access only available materials. If another patron has the eBook checked out, is viewing it or it is on hold, it won't be available to view.
