A member of the public will be allowed to address the Board when the item is called and before action is taken for a total of three (3) minutes per item, unless the President grants more or less time based on the number of people requesting to speak and the business of the Board. When members of the public address the Board on agenda items, the President determines the order in which speakers will be called.
