The President may order the removal (by muting or disconnection of the telephone line) of any person who disrupts or disturbs the orderly conduct of the Board Meeting.

Library's Financial Statements for FY2021-22

SUMMARY

The Board is asked to ratify the engagement of The Pun Group, LLP's to audit the Law Library's financial statements for the fiscal year ended 6/30/22 and accept the auditor's required communication, AU-C260 planning letter.

ANALYSIS AND DETAIL

On July 22, 2020 and following an RFP process the Board selected The Pun Group, LLP as its financial auditor beginning with fiscal year ending June 30, 2020. The RFP called for, and The Pun Group responded with, fee proposals for fiscal years 2019-20, 2020-21 and 2021-22. The Pun Group has proposed terms and conditions to audit the Law Library's financial statements for the fiscal year 2021-22 (see attached). Except for the dates and fee amount, the body of the proposed letter is identical to last year's letter.

As previously proposed in their response to our RFP, The Pun Group, LLP requested a fixed fee of \$19,000 for the fiscal year 2021-22 financial audit. Pursuant to the Library's Governance Resolution, the Board must ratify the engagement and will be responsible for approving the audit report that results. This matter was agendized for the Board's consideration at the July 27, 2022 Board meeting, but the meeting could not proceed for lack of a quorum. The Executive Director then signed the engagement letter to allow the audit to move forward in a timely fashion. Should the Board ratify the engagement, the audit will proceed according to schedule. Should the Board choose to disapprove the engagement, The Pun Group would be paid for whatever work has been completed to date and a new auditor would need to be retained.

The audit field work is scheduled to begin on the week of August 22nd. The audit report is expected to be presented to the Board at its October 26, 2022 meeting.

In addition, and prior to completion of the audit field work, staff also requests the Board accept the auditor's required communication, AU-C260 planning letter (see attached).



RECOMMENDATION

Staff recommends that the Board authorize and ratify execution of the attached engagement letter and accept the auditor's required communication, AU-C260 planning letter.

We are pleased to confirm our understanding of the services we are to provide the Los Angeles County Law Library (the "Library") for the year ended June 30, 2022.

Audit Scope and Objectives

We will audit the financial statements of the business-type activities including the related notes to the financial statements, which collectively comprise the basic financial statements of the Library as of and for the year ended June 30, 2022.

Accounting standards generally accepted in the United States of America ("GAAP") provide for certain Required Supplementary Information ("RSI"), such as Management's Discussion and Analysis ("MD&A"), to supplement the Library's basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. As part of our engagement, we will apply certain limited procedures to the Library's RSI in accordance with auditing standards generally accepted in the United States of America ("GAAS"). These limited procedures will consist of inquiries of management regarding the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We will not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance. The following RSI is required by U.S. generally accepted accounting principles and will be subjected to certain limited procedures, but will not be audited:

- 1) Management's Discussion and Analysis
- 2) Schedule of the Law Library's Proportionate Share of the Net Pension Liability
- 3) Schedule of Contributions Pensions
- 4) Schedule of Changes in Net Other Postemployment Benefits Liability and Related Ratios
- 5) Schedule of Contributions Other Postemployment Benefits Plan

The objectives of our audit are to obtain reasonable assurance as to whether the financial statements as a whole are free from material misstatement, whether due to fraud or error; and issue an auditor's report that includes our opinions as to whether your financial statements are fairly presented, in all material respects, in conformity with GAAP. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS and *Government Auditing Standards* will always detect a material misstatement when it exists. Misstatements, including omissions, can arise from fraud or error and are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment of a reasonable user made based on the financial statements.





The objective also includes reporting on internal control over financial reporting and compliance with provisions of laws, regulations, contracts, and award agreements, noncompliance with which could have a material effect on the financial statements in accordance with *Government Auditing Standards*.

Auditor's Responsibilities for the Audit of the Financial Statements

We will conduct our audit in accordance with GAAS; the standards for financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States, and will include tests of the accounting records of the Library and other procedures we consider necessary to enable us to express such opinions. As part of an audit in accordance with GAAS and *Government Auditing Standards*, we exercise professional Judgment and maintain professional skepticism throughout the audit.

We will evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management. We will also evaluate the overall presentation of the financial statements, including the disclosures, and determine whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation. We will plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement, whether from (1) errors, (2) fraudulent financial reporting, (3) misappropriation of assets, or (4) violations of laws or governmental regulations that are attributable to the government or to acts by management or employees acting on behalf of the government. Because the determination of waste and abuse is subjective, *Government Auditing Standards* do not expect auditors to provide reasonable assurance of detecting waste or abuse.

Because of the inherent limitations of an audit, combined with the inherent limitations of internal control, and because we will not perform a detailed examination of all transactions, an unavoidable risk exists that some material misstatements or noncompliance may exist and not be detected by us, even though the audit is properly planned and performed in accordance with U.S. generally accepted auditing standards and *Government Auditing Standards*. In addition, an audit is not designed to detect immaterial misstatements or violations of laws or governmental regulations that do not have a direct and material effect on the financial statements or on major programs. However, we will inform the appropriate level of management of any material errors, any fraudulent financial reporting, or misappropriation of assets that come to our attention. We will also inform the appropriate level of management of any violations of laws or governmental regulations that come to our attention, unless clearly inconsequential. Our responsibility as auditors is limited to the period covered by our audit and does not extend to any later periods for which we are not engaged as auditors.

We will also conclude, based on the audit evidence obtained, whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the government's ability to continue as a going concern for a reasonable period of time.

Our procedures will include tests of documentary evidence supporting the transactions recorded in the accounts, and may include tests of the physical existence of inventories, and direct confirmation of receivables and certain other assets and liabilities by correspondence with selected individuals, funding sources, creditors, and financial institutions. We will also request written representations from your attorneys as part of the engagement.

Our audit of financial statements does not relieve you of your responsibilities.

Audit Procedures – Internal Control

We will obtain an understanding of the government and its environment, including internal control relevant to the audit, sufficient to identify and assess the risks of material misstatement of the financial statements, whether due to error or fraud, and to design and perform audit procedures responsive to those risks and obtain evidence that is sufficient and appropriate to provide a basis for our opinions. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentation, or the override of internal control. Tests of controls may be performed to test the effectiveness of certain controls that we consider relevant to preventing and detecting errors and fraud that are material to the financial statements and to preventing and detecting misstatements resulting from illegal acts and other noncompliance matters that have a direct and material effect on the financial statements. Our tests, if performed, will be less in scope than would be necessary to render an opinion on internal control and, accordingly, no opinion will be expressed in our report on internal control issued pursuant to *Government Auditing Standards*. An audit is not designed to provide assurance on internal control or to identify significant deficiencies or material weaknesses. Accordingly, we will express no such opinion. However, during the audit, we will communicate to management and those charged with governance internal control related matters that are required to be communicated under AICPA professional standards and *Government Auditing Standards*.

Audit Procedures - Compliance

As part of obtaining reasonable assurance about whether the financial statements are free of material misstatement, we will perform tests of the Library's compliance with the provisions of applicable laws, regulations, contracts, agreements, and grants. However, the objective of our audit will not be to provide an opinion on overall compliance and we will not express such an opinion in our report on compliance issued pursuant to *Government Auditing Standards*.

Other Nonaudit Services

We will also assist in preparing the financial statements and related notes, GASB 68/75 worksheets and journal entries of the Library in conformity with accounting principles generally accepted in the United States of America based on information provided by you. These nonaudit services do not constitute an audit under *Government Auditing Standards* and such services will not be conducted in accordance with *Government Auditing Standards*. We will perform the services in accordance with applicable professional standards. The other services are limited to the financial statement services previously defined. We, in our sole professional judgment, reserve the right to refuse to perform any procedure or take any action that could be construed as assuming management responsibilities.

You agree to assume all management responsibilities relating to the financial statements and related notes and any other nonaudit services we provide. You will be required to acknowledge in the management representation letter our assistance with preparation of the financial statements and related notes and that you have reviewed and approved the financial statements and related notes prior to their issuance and have accepted responsibility for them. Further, you agree to oversee the nonaudit services by designating an individual, preferably from senior management, with suitable skill, knowledge, or experience; evaluate the adequacy and results of those services; and accept responsibility for them.

Responsibilities of Management for the Financial Statement

Our audit will be conducted on the basis that you acknowledge and understand your responsibility for designing, implementing, establishing, and maintaining effective internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error, and for evaluating and monitoring ongoing activities to help ensure that appropriate goals and objectives are met; following laws and regulations; and ensuring that management and financial information is reliable and properly reported. Management is also responsible for implementing systems designed to achieve compliance with applicable laws, regulations, contracts, and grant agreements. You are also responsible for the selection and application of accounting principles, for the preparation and fair presentation of the financial statements and all accompanying information in conformity with accounting principles generally accepted in the United States of America, and for compliance with applicable laws and regulations and the provisions of contracts and grant agreements.

Management is responsible for making drafts of financial statements, all financial records, and related information available to us and for the accuracy and completeness of that information (including information from outside of the general and subsidiary ledgers). You are also responsible for providing us with (1) access to all information of which you are aware that is relevant to the preparation and fair presentation of the financial statements, such as records, documentation, identification of all related parties and all related-party relationships and transactions, and other matters; (2) additional information that we may request for the purpose of the audit; and (3) unrestricted access to persons within the government from whom we determine it necessary to obtain audit evidence. At the conclusion of our audit, we will require certain written representations from you about your responsibilities for the financial statements; compliance with laws, regulations, contracts, and grant agreements; and other responsibilities required by GAAS and *Government Auditing Standards*.

Your responsibilities include adjusting the financial statements to correct material misstatements and confirming to us in the management representation letter that the effects of any uncorrected misstatements aggregated by us during the current engagement and pertaining to the latest period presented are immaterial, both individually and in the aggregate, to the financial statements of each opinion unit as a whole.

You are responsible for the design and implementation of programs and controls to prevent and detect fraud, and for informing us about all known or suspected fraud affecting the government involving (1) management, (2) employees who have significant roles in internal control, and (3) others where the fraud could have a material effect on the financial statements. Your responsibilities include informing us of your knowledge of any allegations of fraud or suspected fraud affecting the government received in communications from employees, former employees, grantors, regulators, or others. In addition, you are responsible for identifying and ensuring that the government complies with applicable laws, regulations, contracts, agreements, and grants and for taking timely and appropriate steps to remedy fraud and noncompliance with provisions of laws, regulations, contracts, and grant agreements that we report.

Management is responsible for establishing and maintaining a process for tracking the status of audit findings and recommendations. Management is also responsible for identifying and providing report copies of previous financial audits, attestation engagements, performance audits, or other studies related to the objectives discussed in the Audit Objectives section of this letter. This responsibility includes relaying to us corrective actions taken to address significant findings and recommendations resulting from those audits, attestation engagements, performance audits, or studies. You are also responsible for providing management's views on our current findings, conclusions, and recommendations, as well as your planned corrective actions, for the report, and for the timing and format for providing that information.

Third-Party Service Provider

We may from time to time, and depending on the circumstances, use third-party service providers in serving your account. We may share confidential information about you with these service providers, but remain committed to maintaining the confidentiality and security of your information. Accordingly, we maintain internal policies, procedures, and safeguards to protect the confidentiality of your personal information. In addition, we will secure confidentiality agreements with all service providers to maintain the confidentiality of your information and we will take reasonable precautions to determine that they have appropriate procedures in place to prevent the unauthorized release of your confidential information to others. In the event that we are unable to secure an appropriate confidentiality agreement, you will be asked to provide your consent prior to the sharing of your confidential information with the third-party service provider. Furthermore, we will remain responsible for the work provided by any such third-party service providers.

Assistance By Your Personnel

We understand that your employees will prepare all cash, accounts receivable, or other confirmations we request and will locate any documents selected by us for testing. We will ask that your personnel, to the extent possible, prepare required schedules and analyses, and make selected invoices and other required documents available to our staff. This assistance by your personnel will serve to facilitate the progress of our work and minimize our time requirements.

Independence

Professional standards require that a firm and its members maintain independence throughout the duration of the professional relationship with a client. In order to preserve the integrity of our relationship, no offer of employment shall be discussed with any the Firm's professionals assigned to the audit, during the one year period prior to the commencement of the year end audit. Should such an offer of employment be made, or employment commences during the indicated time period, we will consider this an indication that our independence has been compromised. As such, we may be required to recall our auditors' report due to our lack of independence. In the event additional work is required to satisfy independence requirements, such work will be billed at our standard hourly rates.

Reporting Distribution and Other

We will provide copies of our reports to the Library, management is responsible for distribution of the reports and the financial statements. Unless restricted by law or regulation, or containing privileged and confidential information, copies of our reports are to be made available for public inspection.

Access to Working Papers

The audit documentation for this engagement is the property of the Firm and constitutes confidential information. However, subject to applicable laws and regulations, audit documentation and appropriate individuals will be made available upon request and in a timely manner to the Regulator or its designee, a federal agency providing direct or indirect funding, or the U.S. Government Accountability Office for purposes of a quality review of the audit, to resolve audit findings, or to carry out oversight responsibilities. We will notify you of any such request. If requested, access to such audit documentation will be provided under the supervision of the Firm personnel. Furthermore, upon request, we may provide copies of selected audit documentation to the aforementioned parties. These parties may intend, or decide, to distribute the copies or information contained therein to others, including other governmental agencies.

The audit documentation for this engagement will be retained for a minimum of seven years after the report release date or for any additional period requested by the U.S. Department of Justice. If we are aware that a federal awarding agency, pass-through entity, or auditee is contesting an audit finding, we will contact the party(ies) contesting the audit finding for guidance prior to destroying the audit documentation.

The Firm is required to undergo a "peer review" every three years. During the course of a peer review engagement, selected working papers and financial reports, on a sample basis, will be inspected by an outside party on a confidential basis. Consequently, the accounting and/or auditing work we performed for you may be selected. Your signing this letter represents your acknowledgement and permission to allow such access should your engagement be selected for review. As a result of our prior or future services to you, we may be required or requested to provide information or documents to you or a third-party in connection with a legal or administrative proceeding (including a grand jury investigation) in which we are not a party. If this occurs, our efforts in complying with such request or demands will be deemed a part of this engagement and we shall be entitled to compensation for our time and reimbursement for our reasonable out-of-pocket expenditures (including legal fees) in complying with such request or demand. This is not intended, however, to relieve us of our duty to observe the confidentiality requirements of our profession.

Fees

Our fee for these services will be \$19,000 for the year ended June 30, 2022. Our fees are based on certain assumptions, including the required assistance described above. To the extent that certain circumstances included but not limited to those listed in Appendix A, arise during the engagement, our fee estimate may be significantly affected and additional fees may be necessary. Additional services provided beyond the described scope of services will be billed separately.

Our invoices for these fees will be rendered each month as work progresses and are payable on presentation. In accordance with our firm policies, work may be suspended if your account becomes 60 days or more overdue and may not be resumed until your account is paid in full. If we elect to terminate our services for nonpayment, our engagement will be deemed to have been completed upon written notification of termination, even if we have not completed our report(s). You will be obligated to compensate us for all time expended and to reimburse us for all out-of-pocket costs through the date of termination.

If the Library is required to undergo a single audit in accordance with the Federal Single Audit Act and the Uniform Guidance, there will be an additional fee of \$4,000 for each major program. The number of programs determined to be a major program will be based on the determination required by the Uniform Guidance and will be discussed with you prior to commencement of any audit work.

The above fee is based on anticipated cooperation from your personnel and the assumption that unexpected circumstances will not be encountered during the audit. If significant additional time is necessary, we will discuss it with you and arrive at a new fee estimate before we incur the additional costs.

Termination

We acknowledge the Library's right to terminate our services at any time, and the Library acknowledges our right to resign at any time (including instances where in our judgment, our independence has been impaired or we can no longer rely on the integrity of management), subject in either case to our right to payment for all direct and indirect charges incurred through the date of termination or resignation or thereafter as circumstances and this agreement may require, plus applicable interest, costs, fees and attorneys' fees.

Dispute Resolution Procedure, Waiver of Jury Trial, Jurisdiction and Venue for All Disputes, and Governing Law

We appreciate the opportunity to serve as the Library's auditor and anticipate a productive, harmonious relationship. If the Library becomes dissatisfied for any reason with the services we have performed or the fees charged, we encourage the Library to bring that to our attention immediately. Most such problems should be remedied by communication and discussion. However, a dispute could arise between us, regarding the construction or application of this agreement and/or the performance of any services under this agreement, which cannot be resolved by discussion. The Library and this Firm believe that such accountant-client disputes are more satisfactorily resolved through confidential, binding arbitration than by litigation in court. Therefore, the Organization and this Firm choose confidential binding arbitration to resolve such disputes. It is understood and agreed that choosing binding arbitration waives a trial by jury.

The place of the confidential binding arbitration will be JAMS in Orange County, California. Arbitration proceedings may be commenced by either the Library or this Firm, by giving all other interested parties written notice; and the proceedings shall be governed by the California Arbitration Act (*Code Civ. Proc.*, § 1281 *et seq.*), except as is otherwise specified herein. The arbitrator must decide all disputes in accordance with the California Arbitration Act, and the applicable rules of JAMS (except to the extent such rules conflict with this arbitration agreement). The arbitrator shall have the power to decide all matters, including legal questions raised by pleading or summary judgment motions. That decision shall be in accordance with California law; and the California *Evidence Code* shall govern all proceedings before the arbitrator. The arbitrator's award shall be final and binding, and a judgment upon the award may be entered and enforced by any court of competent jurisdiction.

By entering into this arbitration agreement, the Library and this Firm expressly waive the right to commence an action in court, except with respect to provisional remedies; and waive the right to trial by jury.

The Library and this Firm each agree to submit to the jurisdiction of any state or federal court in Orange County, California, in any action or proceeding arising out of or relating to the enforcement of the arbitration provisions of this agreement, or for any other purpose. The Library and this Firm agree not to bring any action or proceeding of any kind in any other court. The Library and this Firm waive any defense of inconvenient forum to the maintenance of any action or proceeding in Orange County, California.

Other Services

We are always available to meet with the Library and/or other management personnel at various times throughout the year to discuss current business, operational, accounting and auditing matters affecting the Library. Whenever such a meeting is desirable, please let us know; we are prepared to provide services to assist the Library in any of these areas.

Most Recent External Quality Control Review

Government Auditing Standards require that we provide the Library with a copy of our most recent external peer review report and any letter of comment, and any subsequent peer review reports and letters of comment received during the period of the contract.

You have requested that we provide you with a copy of our most recent external peer review report and any subsequent reports received during the contract period. Accordingly, our 2021 peer review report accompanies this letter.

Reporting

We will issue a written report upon completion of our audit of the Library 's financial statements. Our report will be addressed to the Board of Trustees of the Library. Circumstances may arise in which our report may differ from its expected form and content based on the results of our audit. Depending on the nature of these circumstances, it may be necessary for us to modify our opinions, add a separate section, or add an emphasis-of-matter or other-matter paragraph to our auditor's report, or if necessary, withdraw from this engagement. If our opinions are other than unmodified, we will discuss the reasons with you in advance. If, for any reason, we are unable to complete the audit or are unable to form or have not formed opinions, we may decline to express opinions or issue reports, or we may withdraw from this engagement.

We will also provide a report (that does not include an opinion) on internal control related to the financial statements and compliance with the provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a material effect on the financial statements as required by *Government Auditing Standards*. The report on internal control and on compliance and other matters will state (1) that the purpose of the report is solely to describe the scope of testing of internal control and compliance, and the results of that testing, and not to provide an opinion on the effectiveness of the entity's internal control on compliance, and (2) that the report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the entity's internal control and compliance. The report will also state that the report is not suitable for any other purpose. If during our audit we become aware that the Library is subject to an audit requirement that is not encompassed in the terms of this engagement, we will communicate to management and those charged with governance that an audit in accordance with U.S. generally accepted auditing standards and the standards for financial audits contained in *Government Auditing Standards* may not satisfy the relevant legal, regulatory, or contractual requirements.

Agreement

It is hereby understood and agreed that this engagement is being undertaken solely for the benefit of the Library and that no other person or entity shall be authorized to enforce the terms of this engagement.

We are engaged to audit the financial statements of the business-type activities of the Los Angeles County Law Library (the "Library") for the year ended June 30, 2022. Professional standards require that we provide you with the following information related to our audit. We would also appreciate the opportunity to meet with you to discuss this information further since a two-way dialogue can provide valuable information for the audit process.

Our Responsibility under U.S. Generally Accepted Auditing Standards and Government Auditing Standards

As stated in our engagement letter dated July 6, 2022, our responsibility, as described by professional standards, is to express opinions about whether the financial statements prepared by management with your oversight are fairly presented, in all material respects, in conformity with U.S. generally accepted accounting principles. Our audit of the financial statements does not relieve you or management of your responsibilities.

As part of our audit, we will consider the internal control of the Library. Such considerations are solely for the purpose of determining our audit procedures and not to provide any assurance concerning such internal control.

As part of obtaining reasonable assurance about whether the financial statements are free of material misstatement, we will also perform tests of the Library's compliance with certain provisions of laws, regulations, contracts, and grants. However, providing an opinion on compliance with those provisions is not an objective of our audit.

Generally accepted accounting principles provide for certain Required Supplementary Information ("RSI") to supplement the basic financial statements. Our responsibility with respect to Management's Discussion and Analysis, the Schedule of the Law Library's Proportionate Share of the Net Pension Liability, the Schedule of Contributions – Pensions, the Schedule of Changes in Net Other Postemployment Benefits Liability and Related Ratios, and the Schedule of Contributions – Other Postemployment Benefits Plan, which supplement the basic financial statements, is to apply certain limited procedures in accordance with generally accepted auditing standards. However, the RSI will not be audited and, because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance, we will not express an opinion or provide any assurance on the RSI.

Planned Scope and Timing of the Audit

An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements; therefore, our audit will involve judgment about the number of transactions to be examined and the areas to be tested.

Our audit will include obtaining an understanding of the entity and its environment, including internal control, sufficient to assess the risks of material misstatement of the financial statements and to design the nature, timing, and extent of further audit procedures. Material misstatements may result from (1) errors, (2) fraudulent financial reporting, (3) misappropriation of assets, or (4) violations of laws or governmental regulations that are attributable to the entity or to acts by management or employees acting on behalf of the entity. Because the determination of waste and abuse is subjective, *Government Auditing Standards* do not expect auditors to perform specific procedures to detect waste or abuse in financial audits not do they expect auditors to provide reasonable assurance of detecting waste or abuse. We will generally communicate our significant findings at the conclusion of the audit. However, some matters could be communicated sooner, particularly if significant difficulties are encountered during the audit where assistance is needed to overcome the difficulties or if the difficulties may lead to a modified opinion. We will also communicate any internal control related matters that are required to be communicated under professional standards.

We have identified the following significant risk of material misstatement as part of our auditing planning:

- Implementation of Government Accounting Standards Board Statement No. 87 Leases.
- Allowance for doubtful accounts and bad debt expenses.

INTRODUCTORY INFORMATION

For over 130 years the Los Angeles County Law Library ("LA Law Library") has served the Los Angeles County government, legal and business communities and the general public, including self-represented litigants. LA Law Library offers free access to legal information, resources, training and support to all members of the community, with no income or subject matter restrictions, under the motto:

Access to Information = Access to Justice

LA Law Library is:

- A vibrant community education center, offering classes for attorneys,
 paralegals, librarians and the general public;
- A navigator facilitating access to the legal system for those who do not have or cannot afford legal representation;
- A leader in providing public access to legal knowledge;
- The largest public Law Library in the United States other than the Law Library of Congress; and
- The curator and cultivator of nearly one million volume equivalents -- including one of the nation's most comprehensive global law collections covering more than 200 countries.

LA Law Library annually provides supportive interactions, reference consultations, classes, workshops and online assistance to more than 100 thousand individuals – and the number continues to grow daily as new programs and workshops are developed with the assistance of the Library's many partners and donors.

LOCATIONS AND HOURS

The Main Law Library is located in the Mildred L. Lillie Building at First & Hill, 301 West First Street, Los Angeles, California, across the street from the Stanley Mosk Courthouse of the Los Angeles Superior Court. The Main Library includes approximately 175,000 square feet and 35 miles of shelving.

The Law Library also has twelve other locations throughout the County. A few of these locations have an electronic research center, called an eBranch, which is a walk-up



computer-based, interactive research experience. eBranch users can contact LA Law Reference Librarians remotely via chat service, or during on-site office hours. The branch and partnership locations can be found in:

Four courthouse branch locations:

- Long Beach and Torrance (eBranch and staff)
- Norwalk and Pomona (eBranch only)

Nine partnership locations:

- Los Angeles Public Library in Van Nuys
- Los Angeles County Public Libraries in Compton, Lancaster,
 Norwalk and West Covina
- Pasadena Public Library
- Pomona Public Library
- Santa Monica Public Library

During fiscal year 2021-2022, the Law Library offered a mix of in-person and remote services. The Main Law Library was open to the public Monday through Friday, 8:30 a.m. until 6:00 p.m., and remotely on Saturdays from 9:00 a.m. to 5:00 p.m. Services were accessible via email, telephone, live chat, online classes, workshops and will-call pickup of collection materials. LA Law Library resumed in-person borrowing of print materials shortly after the fiscal year began and phased out our will-call program. The Law Library also waived overdue book fees incurred prior to the library's reopening in order to alleviate any financial strain experienced by patrons who could not access the Library during the pandemic.

The Main Library maintained in-person assistance throughout the fiscal year. In-person assistance resumed at Torrance Branch in December 2021 and continues to be on hiatus at Long Beach branch and public library partnership locations. It is anticipated that Long Beach branch will resume office hours and in-person assistance during the 2nd quarter of Fiscal Year 23 and partner locations will resume office hours and on-site assistance during the 3rd quarter of Fiscal Year 23



PROGRAMS AND SERVICES

Reference Assistance: The Law Library provides reference and research assistance inperson and by phone, mail, email and live web-chat. These services are available at no
charge to any and all users of the library, including attorneys, legal professionals,
students and, most frequently, the general public. Although Reference Librarians do not
provide legal advice, they do leverage their knowledge of the law and legal research to
provide legal information, resources and instruction to any member of the public who
needs assistance on any legal topic, and do so efficiently, compassionately, and
professionally.

<u>Support Services</u>: The Law Library also makes available free public computers and Wi-Fi, as well as copiers, printers, office supplies, faxing service, document delivery and edelivery for a small fee. The Law Library continued waiving e-delivery fees for scanned materials for one request per day per patron to allow continued free access to resources as a response to COVID-19.

Classes and Programs: The reference staff and our roster of volunteer speakers provide instruction to the general public on a range of topics designed to expand access to legal information and therefore access to justice. Our recurring classes and programs are delivered both in-person and in online, remote formats. Most recordings and live webinars hosted by the Library are accessed at no cost. Classes offered cover topics including the basics of court procedure, as well as common legal issues like eviction protections, consumer credit challenges, domestic violence, elder abuse, how to find the answers to legal questions using library and online resources, and much more. While the Law Library offered classes only remotely during the pandemic, the Library resumed socially-distanced, on-site classes on most topics in order to serve those patrons adversely affected by the digital divide and most in need of in-person assistance.

The Law Library, supported by many partners within the legal community, also provides law-related informational and clinical classes and workshops for its diverse patron groups:

For Attorneys, Paralegals and Certified Court Interpreters: The Law Library provides State Bar-certified Minimum Continuing Legal Education (MCLE) classes on a diverse set of topics designed to serve the needs of attorneys and paralegals in all practice areas, with an emphasis on subjects that expand access to justice for disadvantaged groups or those unable to afford legal representation. The Library also offers Court Interpreter Minimum Continuing Education (CIMCE) credit for classes on court procedures and common legal issues to help court interpreters better serve their clients and the courts.

Fiscal Year 2021-22 featured 13 live MCLE certified class sessions, plus another 17 prerecorded programs available to watch online. Sessions covered topics such as how to help
veterans remove obstacles to employment; establishing guardianships; legal efforts to
address homelessness; how to identify and address elder abuse, plus lectures from notable
speakers on hot topics like recent, major U.S. Supreme Court decisions and hair and dress
rules in school and workplace. The year also featured 10 CIMCE-certified class sessions
covering fundamental legal topics such as filing and responding to civil complaints,
representing oneself civil trials, basics of landlord-tenant law, dealing with debt, and
probate court procedures.

<u>For Self-Represented Individuals:</u> Prior to COVID-19, the Law Library provided workshops, clinics and programs on a frequent recurring basis, including:

- Weekly: Talk to a Lawyer Online (videoconferencing with Legal Aid Foundation of Los Angeles) and Adult Legal Conservatorship Clinic presented by Bet Tzedek;
- Bi-weekly: Civil Lawsuit Basics (main and branch locations), and Common Legal Issues: Where You Begin;
- Monthly: asylum petition workshop for immigrants facing deportation; name change workshop; expungement clinic; divorce options workshop (main and branch locations);; Lawyers in the Library (free consultations with volunteer lawyers);
- Occasional Series and Sessions: Public Defender's clinic to provide
 help in filling out expungement forms, reducing nonviolent felonies to
 misdemeanors through Prop 47 and getting some marijuana offenses
 cleared under Prop 64; Probate guardianship clinic to assist

unrepresented persons in becoming a minor's legal guardian; Landlord & Tenant Series: Rights, Responsibilities, Fair Housing and Section 8; and Small Claims 101; Appellate self-help workshops classes, including one-on-one assistance with brief-writing;

 Quicklook legal research classes and librarian office hours offered in branch and community public library locations;

The COVID pandemic greatly impacted in-person workshops, clinics and programs because face-to-face consultations were no longer possible. In response, many of the most popular recurring programs listed are offered in virtual format through the Library's website. These include the Civil Lawsuit Basics, Where You Begin series and adult name change workshop. In response to COVID-19, the Library also created new online programs on legal topics especially relevant during the pandemic, including classes on new and established employment protections, employment benefits, and landlord-tenant protections. These continue to be offered.

Lawyers in the Library was originally an in-person program but was converted to a remote service via internet and telephone when COVID prevented in-person consultations. The Library has resumed in-person Lawyers in the Library on the third Friday of the month so patrons now have a choice of in-person or remote consultations via internet and telephone. In either format, volunteer attorneys provide free 15-20 minute consultations with members of the public. The program has grown so dramatically – due in part to the increased need for COVID-related legal support services – that many regular volunteers now provide consultations on an ongoing weekly basis. The most heavily requested topics are family law, landlord-tenant and restraining orders for protection. The Library is also getting questions regarding criminal matters, small business issues, employment law, real estate, probate, credit issues, contracts and many other topics.

In response to the need for remote, but individualized, legal assistance, the Library also hosts "Ask a Lawyer" sessions: subject-specific, "town-hall"-style Zoom sessions, where anyone with a question on the subject of the session can attend and ask their question to a lawyer with experience in that area. This type of program is highly efficient and allows our volunteers to help many people in the course of an hour. Since launching with a session on landlord-tenant protections during COVID-19, the program has expanded to



include not just landlord-tenant sessions, but also monthly sessions on probate, wills and trusts, civil rights, employment discrimination and small claims.

<u>For Business People and Entrepreneurs:</u> The Law Library provides classes and workshops, including:

• Starting & Growing a Business: Legal & Financial Knowledge You Need to Succeed (14-part biannual series) in partnership with L.A. County Department of Consumer & Business Affairs, L.A. Ports TradeConnect, and the L.A. Mayor's Office of Economic Development

These classes are now offered online in live Zoom format and as recordings.

<u>For the Entire Community:</u> The Law Library provides free community events, aimed at promoting equal access to justice throughout Los Angeles County:

- held throughout the year where everyone is invited to learn about the many different ways the law and the legal system work to ensure justice in our society and throughout the world. In 2021-2022, the Library marked Freedom of Information Day and Law Day with full line-ups of in-person and remote programs. LA Law Library's Law Day celebration featured an information session on the court process for becoming an adult's legal conservator; an in-person Lawyers in the Library; a live Zoom class on filing a defamation lawsuit; an MCLE on new U.S. Supreme Court decisions and an internally taught class on due process from the Library's on-demand video series. The Library celebrated Freedom of Information Day with classes on legal research, accessing court records, a live Zoom "town-hall"-style Ask a Lawyer session about the Public Records Act and an on-demand class on accessing police personnel files.
- Pro Bono Week in October: Every October -- usually in person, but
 predominantly online since the pandemic -- we provide a huge array of
 programs and services for those who need help understanding their rights,
 representing themselves and accessing the justice system. It's our way of
 celebrating the American Bar Association's national Pro Bono Week and
 all the volunteer attorneys, non-profit legal organizations and social

services representatives who provide free legal information and assistance in our community. During our week-long Pro Bono Week celebration, the Library hosts free events offering opportunities for one-on-one assistance, consultation with an attorney, education about the law and discussions on timely topics in the law. There are also numerous offerings during Pro Bono Week providing training to volunteers so that they can engage in pro bono activities with the Law Library and many other organizations participating in our Pro Bono Week celebration.

Prior to the pandemic, the capstone event was the annual Public Legal Services Fair which connects members of the public to a vast array of much-needed legal and social services. The Public Legal Services Fair brought together legal aid organizations, government agencies, as well as social services and community-based groups to provide free services and information to the public. In lieu of the Public Legal Services Fair, this year the culminating event for the 2022 Pro Bono Week celebration was a full day's line-up of Zoom "town-hall" style Ask a Lawyer sessions covering child support and custody, immigration and citizenship, criminal law, landlord-tenant/housing and probate, wills and trusts.

Despite the limitations of the pandemic, Fiscal Year 2021-2022 saw continued strong attendance for our programs. In total, classes and clinics at the law library provided instruction and assistance to more than 5,000 attendees this last fiscal year, all of which consisted of live or asynchronous online attendance due to Covid-19.

Members Program: The Law Library offers a Members Program, which uses an affordable fee-for-service model to provide quiet work and meeting space adjacent to the downtown courthouses; unlimited access to the law collection and legal databases onsite; off-site access to certain databases; priority reference service; plus, discounts on services, classes, and parking. While open to the general public, the program serves to provide affordable support to attorneys serving modest-means clients, especially newer members of the bar, who are engaged in offering new and innovative representation models for litigants who might otherwise be unable to afford legal help. In addition to the established Members Program, a second Platinum Members Program is offered to address the needs of larger firms by providing unlimited access to LA Law Library's unparalleled collection. In addition to several of the benefits afforded the core individual

Members Program, the flat-fee based Platinum Membership model provides all-inclusive, unlimited e-delivery of digital documents, as well as e-delivery of scanned material from our extensive LA Law Library collection, all for a flat monthly fee. The Members Program has continued to provide uninterrupted value and service to the legal community in Los Angeles County during COVID-19, with most services offered remotely.

Law and Library School Internship programs:

LA Law Library traditionally hosts law and library school interns 3-4 times per year. Under the supervision of professional librarians, an internship at the library offers an optimal field environment for obtaining practical hands-on experience working with a collection of approximately 1 million volume-equivalents, learning effective reference skills, honing their communication techniques, interacting with a diverse public, and exploring collection development and management practices. Within the framework of these internships, library school students benefit from the opportunity to explore career options as a special librarian and law school students have the opportunity to interact with and learn how and where public service can fit into building a successful law practice.

Beginning in 2020, the library converted what is traditionally a hands-on, front-facing staff and patron experience to a virtual one. In 2022, the library implemented a hybrid program, which allowed those without the means to regularly participate on-site the opportunity to complete a law library internship successfully. In July, 2022, at the American Association of Law Libraries' annual meeting, LA Law Library staff presented on the library's internship program as a reliable resource and model for building a law librarianship career pipeline.

Room Rentals: The Law Library rents private office space, conference rooms, classroom or Training Center and larger Reading Room for meetings and special events. These services were put on hold in response to COVID-19 and the stay-at-home orders and have not yet resumed.

<u>Tours</u>: Library staff also gives library orientations and stack tours to outside groups including bar associations, paralegal students and law-related student groups and academic institutions. These services were put on hold in response to the pandemic and have not yet fully resumed.

LIBRARY USAGE

The Law Library is open to all members of the public, and use of the library materials, including the computers and legal databases, is free. A library card is needed to access the computers (2-hour limit per day) and to borrow print or digital books. Borrowing of print materials requires a refundable security deposit, while e-books access is available using a free version of our library card.

At the end of Fiscal Year 2021-2022 there were 18,273 library cardholders without borrowing privileges of print materials. At the end of Fiscal Year 2021-2022, there were also 897 persons registered as individual borrowers, including 559 attorneys. In addition, 134 law firm and business borrowers have identified 747 designated borrowers, including attorneys, librarians and messenger services. There are 349 judicial borrowers, 410 government borrowers and 2,532 special promotions borrowers.

LA Law Library provides in-person and remote legal research assistance and instruction to tens of thousands of individuals who need help researching legal issues and accessing the legal system. Additionally, we offer access to invaluable legal research resources and databases at our onsite locations at no cost.

The Law Library's services continue to emphasize remote service, including phone, chat, and email, as the County and the world continue to readjust after the pandemic. Prior to the start of the pandemic, we had been serving LA Law Library patrons by phone, email and IM chat services and continued to offer these virtual services to LA Law Library patrons without interruption throughout the pandemic. Our staff continued to work diligently fulfilling our role as a main public source of legal research for the people of Los Angeles County, as well as the State of California more widely. In comparison to an in-person service model, a virtual service model requires more time spent with each patron. Whereas previously, patrons were able to directly access materials in print and digital format, virtual service requires acting as an intermediary, which is more time and resource intensive.

During Fiscal Year 2021-2022, LA Law Library reference staff fielded 29,488 requests for information. 12,243 were in-person inquiries; 11,683 requests were received by phone; 5,368 were email or live-chat; and 194 were letter requests, generally from the incarcerated. The questions came from a diverse group of users that includes self-

represented litigants, attorneys, paralegals, judges, students and the general public.

The circulation department staff issue library cards, check books in and out, respond to requests for computer sign-ups, place books on hold, handle questions about overdue fines and page materials as needed from the library's closed stack areas. In Fiscal Year 2021-2022, 14,354 requests were handled by Circulation, 10,597 were at the desk and 3,757 were telephone or email requests A total of 949 items were placed on hold and 8,364 books were circulated and /or loans renewed. In December, the library rolled out e-book borrowing accessible to all patron groups. Since the roll-out and through the close of the fiscal year, 1,588 e-books were borrowed by patrons and 15 e-books were placed on hold.

In response to requests for materials and information, LA Law Library provides document delivery and e-delivery services. 1,129 such requests were for digital service delivered in Fiscal Year 2021-2022. The LA Law Library Copy Center also responded to 2,402 in person requests producing 77,172 photocopies.

LA Law Library's web site (www.lalawlibrary.org) was visited by more than 62,485 visitors in Fiscal Year 2021-22. The average number of daily visits was 288 with average visit duration of 3:07 minutes. 94.49% of the visitors were from the United States; 5.51% of the visitors were from other countries.

LA Law Library subscribes to 21 online legal databases; these are resources that are not generally available on the internet and therefore would not otherwise be available to self-represented individuals. These databases, including Westlaw and Lexis Advance, are available free of charge at 21 public terminals located in the main library, as well as at eBranches in other locations throughout the County. The main library branch is also a Wi-Fi ready facility with 20 multiplex table outlets throughout the reading room that enable library users to access the Law Library's website, as well as their own programs and documents through personal computers.



COLLECTION / ACQUISITIONS

<u>Print Materials</u>: During Fiscal Year 2021-22, the Main Library added 7,004 volumes; the Branch locations added 45 volumes. During the same period, the library withdrew 2,907 volumes and media from the Main Library and 40 volumes from the Branch locations. At the end of Fiscal Year 2021-22, the total number of print volumes in the LA Law Library collection was 699,105. The Main Library held 698,407; the Branch locations held 698.

Non-Print Materials (Other Than Subscription Databases): During Fiscal Year 2021-22, the main Library added 93 computer discs, and 3,393 ebooks. Additionally, the Law Library added 1 roll of microfilm and 3,613 microfiche to the collection (reflecting a decline in the use of microfilm/microfiche as a commonly-used production medium). At the end of the Fiscal Year 2021-22, the Library held 8,213 reels of microfilm, 1,433,828 microfiche, 1,264 computer discs, 3,393 ebooks, 115 audio discs, and 74 video/DVDs. The Branch locations do not maintain non-print collections (other than subscription databases).

LA Law Library launched Lexis Digital eBooks in FY21-22, our first widespread eBook initiative, giving self-represented individuals and all library patrons the ability to access and borrow over 500 legal research books for free even when they are not in the Law Library. Many high-demand titles that in-library patrons need to wait to use or are checked out frequently are now available electronically, such as *California Forms of Pleading & Practice*, *California Points & Authorities* and *California Legal Forms Transactions*.

<u>Volume Equivalents</u>: The volume equivalent of non-print materials available in microform and ebooks is approximately 314,798 volumes. The grand total of volumes and volume equivalents in the LA Law Library collection is 1,013,903 volumes representing 198,992 titles.

FUNDING

The great majority of the Law Library's services are free of charge, including in-person access to the highly valuable digital and print collection, reference assistance and borrowing.

County Law Libraries are funded by a formula established by the Legislature which



allocates a small portion of the fees generated from initial civil filings in each county to that county's Law Library. Due to a significant decline in the number of filings and an increase in the number of fee waivers statewide, these funds decreased precipitously over the past decade. LA Law Library specifically experienced a decline in civil filing fee revenue of more than \$3 million (roughly 30% of its overall revenue). The initial closure of the courts and other judicial institutions created further declines in filings and backlogs that impact filing fees. LA Law Library and the Council of California County Law Libraries (CCCLL) have once again lobbied the state Legislature for additional funding for County Law Libraries across the state. As a result of that effort, County Law Libraries were allocated \$16.5 million in supplemental general fund money, of which LA Law Library received \$3,175,329.50.

LA Law Library continues to try to develop additional revenue sources including fees for extraordinary library services (such as electronic delivery, room rentals, etc.), programs (such as MCLE classes) and parking in the court-adjacent structure.

GIFTS

During Fiscal Year 2021-2022, although many offers were received, due to duplication, the Law Library did not accept any gifts of legal materials, except for those enumerated here. Member Una Jost donated <u>American Health Law Association's (AHLA) Guide to Health Care Legal Forms, Agreements and Policies.</u> Patron Ron Peng donated <u>Competition Policy in Professional Sports, TV Rights and Sports Legal Aspects</u> and <u>Entertainment Law on a Global Stage</u>.

In addition, the Friends of the Los Angeles County Law Library donated \$145,000 in Fiscal Year 2021-22.

RE: Consideration and Approval of Revised Bylaws of the Friends of

the Los Angeles County Law Library

INTRODUCTION AND SUMMARY

The Board of Trustees is asked to review and consider the attached amended bylaws of the Friends of the Los Angeles County Law Library ("Friends"). The bylaws were last amended and approved by the Board of Trustees in 2009. Article 14 of the bylaws states that any change to the bylaws "that adversely affects the rights granted to the Board of Trustees or the existing directors . . . shall also require the approval of the Board of Trustees." The Board of Directors of the Friends approved the attached amended bylaws at their June 2022 meeting and requested the Trustees to review and provide input if desired.

BACKGROUND AND ANALYSIS

The Friends provided an advance copy of the bylaws to Executive Director Levin and Trustee Liaison, Susan Steinhauser, for review and input prior to finalization. All suggested revisions or edits provided by them were accepted and included in the attached amended bylaws and the Executive Director and Liaison recommend approval.

The proposed changes are intended to modernize and make substantial improvements to the structure and governance of the Friends. They include the addition of a Governance and Board Excellence Committee, provisions addressing the role of Emeritus Directors, additional language regarding diversity, equity and inclusion and modernization of remote meeting and notice options.

The key right of the Board of Trustees is to appoint the majority of the Board of the Friends, known as Trustee-appointed directors. This is not changed nor is the role of the Trustees or the approval process for Trustee-Appointed directors.



However, the proposed changes do change in some aspects the rights of the existing directors, including Trustee-appointed directors, with respect to certain administrative matters and internal operations of the Friends, by:

- Eliminating the fixed date and notice requirement for the annual meeting;
- Reducing the number of directors needed to act without a meeting from all to a majority;
- Removing the power of the Board to appoint an Executive Committee;
- Giving the Executive Committee the power to create committees and appoint members:
- Removing the requirement that the Executive Committee provide written notice
 to all directors of their actions (and substituting instead an announcement at
 the next Board meeting); and
- Eliminating the requirement that committees provide minutes.

The above matters appear to be for the purpose of streamlining operations and making the organization more flexible.

Moreover, these proposed revisions should be viewed in the context of Friends' continued expansion and improvement of the ways in which they support the Law Library. They have undertaken additional projects beyond Gala, including cy pres efforts, grant applications and other projects. Streamlining and modernizing is a part of that overall change.

RECOMMENDATION

The Executive Director and Liaison recommend approval of the attached proposed bylaws.



AMENDED AND RESTATED BYLAWS

OF

FRIENDS OF THE LOS ANGELES COUNTY LAW LIBRARY (a California Nonprofit Public Benefit Corporation)

ARTICLE 1: NAME

The name of this the corporation is Friends of the Los Angeles County Law Library- ("Friends").

ARTICLE 2: PURPOSES

This corporationFriends has been formed for charitable purposes. The creation of this corporationFriends is not intended to supersede state policy regarding funding of county law libraries as provided under California Business and Professions Code Section 6300 et al., (or any successor section to that code, if applicable). This corporationFriends has been formed to raise funds (generally from the private sector) to support the collections, staff, facilities, and programs and services of the Los Angeles County Law Library ("Law Library"); AH-funds raised by the corporation, except those retained for the corporation'sFriends' reasonable administrative and operating expenses, shall be directed towards the Law Library in furtherance of the corporation'sFriends' purpose to support the Law Library's activities of the Law Library. In addition, this corporationFriends is formed for the purposes of performing all things incidental to, or appropriate in, the achievement of achieving the foregoing specific and primary purposes. However, the corporationFriends shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of its primary charitable purposes.

This corporation Friends shall hold and may exercise all such powers as may be conferred upon a nonprofit corporation by the laws of the State of California and as may be necessary or expedient for the administration of the affairs and attainment of the purposes of the corporation, provided, however, that in no event Friends shall the corporation not engage in activities which that are not permitted to be carried on by a corporation exempt under Section 501(c)(3) of the Internal Revenue Code. Additionally, the corporation's Friends' activities shall be limited in the following ways:

- 1. The corporation Friends shall act as a separate corporation in a fundraising capacity to the <u>Law Library Board of Trustees</u>. (the "Board of Trustees").
- 2. The corporationFriends is not the agent of the Law Library or of the Law Library or of the Law Library Board of Trustees (the "Board of Trustees") and shall have no right or authority to bind or contract for the Law Library or the Board of Trustees. The corporation's Friends' support of the Law Library shall not in any way enable it to control the policies, programs or

services offered by the Law Library. The Board of Trustees shall have no right or authority to bind or contract for the Friends, and their primary role shall be as designated in Article 7, Section 3.

ARTICLE 3: PRINCIPAL OFFICE

The initial principal office of the corporation Friends shall be located in the City of Los Angeles, County of Los Angeles, State of California. The Friends' Board of Directors may at any time, or from time to time, change the location of the principal office from one location to another within said city and county.

The Board of Directors may at any time establish branch offices at any place where the corporation Friends is qualified to do business.

ARTICLE 4: NONPARTISAN ACTIVITIES

This corporation Friends has been formed under California Nonprofit Public Benefit Corporation Law, Sections 5110-6910 and any successor sections, as applicable (the "Law") for the charitable purposes described above, and it shall be nonprofit and nonpartisan. No substantial part of the activities of the corporation shall consist of the publication or dissemination of materials with the purpose of attempting to influence legislation, and the corporation Friends shall not participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE 5: DEDICATION OF ASSETS

The properties and assets of this nonprofit corporation are irrevocably dedicated to charitable purposes. No part of the net earnings, properties, or assets of this corporation Friends, on dissolution or otherwise, shall inure to the benefit of any private person or individual, or any member, director Director, or officer of this corporation. Friends. On liquidation or dissolution, all remaining properties and assets of the corporation Friends shall be distributed and paid over to another organization dedicated to charitable purposes that has established its tax-exempt status under Internal Revenue Code Section 501(c)(3).

ARTICLE 6: MEMBERSHIP

The corporation Friends shall not have any members Members within the meaning of Section 5056 of the California Corporations Code. Nothing contained in this Article 6 shall be construed to limit the right of the corporation Friends to refer to persons associated with the corporation Friends as "members" even though such persons are not members, as defined by the Corporations Code, and no such reference shall constitute anyone being a member Member, within the meaning of Section 5056 of the California Corporations Code. Upon designation of criteria for advisory membership by the Board of Directors, the corporation Friends may have advisory members who are not members within the meaning of Section 5056 of the California Corporations Code.

ARTICLE 7: BOARD OF DIRECTORS

Section 1. <u>Powers</u>. Subject to the provisions and limitations of the Law and any other applicable laws, the business and affairs of the corporation Friends shall be managed, and all corporate powers shall be exercised, by or under the direction of the Board of Directors. The Board of Directors may delegate the management of the day-to-day operation of the business of the corporation Friends to a management company, committee employed staff and/or consultants, committees (however composed), or other person persons, provided that the activities and affairs of the corporation Friends shall be managed and all corporate powers shall be exercised under the ultimate direction of the Board of Directors.

Section 2. <u>Number of Directors</u>. <u>Initially, a three (3) member Board of Directors shall govern this corporation</u>. As of the date of the first annual meeting of the directors, the authorized number of directors The authorized number of Directors shall consist of not less than 9 (nine) positions nor more than 25 (twenty-five) positions, the exact number of Directors to be fixed, within the limits specified in this <u>Article 7</u> Section 7-2, by resolution of the Board.

Section 3. <u>Designation and Term of Office of Directors</u>. The initial Board of <u>Directors shall serve until their successors have been appointed and seated at the first annual meeting of the directors</u>. After the first annual meeting of the directors, the <u>The Board of Trustees shall appoint a majority of directors Directors</u> of <u>this corporation Friends</u>; provided, that at no time shall any Board of Trustees members or Law Library officers or employees serve concurrently on the <u>board Board</u> of <u>this corporation Friends</u>. The remaining <u>directors Directors</u> of <u>this corporation Friends</u> shall be <u>self-perpetuating and appointed</u> by the existing <u>directors Directors</u> of <u>this corporation Friends</u> as vacancies occur.

The term of office of each director shall be two (2) years. At the first annual meeting, the directors shall be divided into two (2) groups (one group will be those directors who have been appointed by the Board of Trustees (the "Board of Trustees group" and the other group will be the remaining self-perpetuating directors (the "Self-Perpetuating group"). The Self-Perpetuating group shall initially serve two (2) year terms, and the Board of Trustees group shall initially serve a one (1) year term. Thereafter, the term of office of each director shall be two (2) years. If any annual meeting is not held or the Board of Trustees group or the Self-Perpetuating group is not appointed at the annual meeting, members of the Board of Trustees group or the Self-Perpetuating group may be appointed by the Board of Trustees or the existing directors, as the case may be, at any time thereafter.

The term of office of each Director shall be two (2) years.

Except as otherwise provided in these Bylaws, each <u>director Director</u>, including a <u>director Director</u> appointed to fill a vacancy, shall hold office until expiration of the term for which appointed and until a successor has been appointed and qualified. -Directors may serve <u>any number of consecutive terms so long as Directors appointed by the Board are proposed by the majority vote of the Governance and Board Excellence Committee and then approved by the Board.</u>

The Board of this corporation shall act towards the Board of Trustees in a fundraising capacity only. The Board shall not act as an agent of the Law Library or of the Board of Trustees and shall have no right or authority to bind or contract for the Law Library or the Board of Trustees.

Section 3.1. <u>Board Composition</u>

This corporation's. Friends' Board members shall collectively represent a diversity of relevant(e.g., race, ethnicity, and gender) of backgrounds and include members of the legal and business communities at-large and/or have demonstrated commitment to the Law Library either as patrons, funders or supporters thereof. Every Director shall also actively serve on a Board committee to be determined by the Director and the Governance and Board Excellence Committee.

Section 3.2 Emeritus Directors

From time to time, and in the exercise of its sole discretion, the Board shall have the authority to appoint or remove as Director Emeritus one or more individuals from among current or former Directors, whom the Board shall determine are qualified by virtue of their eminent standing in the community. A Director Emeritus may receive upon request any notices, reports and/or publications sent to members of the Board, and may attend Board meetings as provided in this Section, except for meetings held in executive session. If a Director Emeritus attends a meeting, the Director Emeritus shall not count for the purposes of establishing a quorum and shall not have the right to vote, but shall give the Board the benefit of his or her knowledge and experience in matters affecting the Law Library or the Friends. Directors Emeritus do not count toward the authorized number of Directors set forth in Article 7 Section 2.

Section 4. <u>Vacancies</u>. A vacancy on the <u>boardBoard</u> shall exist <u>on the occurrence</u> of the following: <u>upon</u>: (a) the death, resignation, or removal of any <u>directorDirector</u>; (b) the declaration by resolution of the <u>boardBoard</u> of a vacancy in the office of a <u>directorDirector</u> who has been declared of unsound mind by a final order of court, convicted of a felony, or found by final order or judgment of any court to have breached a duty under Sections 5230-5239 of the Law dealing with standards of conduct for a <u>director</u>, <u>or has missed three (3) consecutive meetings of the Board of Directors or a total of four (4) meetings of the board during any one calendar year; <u>Director</u>, (c) an increase in the authorized number of <u>directorsDirectors</u>; or (d) the failure of the Board of Trustees or the Friends of the Los Angeles County Law Library, at any annual meeting or otherwise, to appoint the full authorized number of <u>directorsDirectors</u>.</u>

The Board of Directors, by affirmative vote of a majority of the <u>directors Directors</u> then in office, may remove any <u>director Director</u> with or without cause at any regular or special meeting; provided that the <u>director Director</u> to be removed and the Board of Trustees have been notified in writing in the manner set forth in Article 7, Section 5 that such action would be considered at the meeting.

Except as provided in this paragraph, any director Director may resign effective upon giving written notice to the chairpersonChair of the boardBoard, the executive director Executive Director, the secretary, or the Board of Directors, unless the notice specifies a later time for the effectiveness of the resignation. Friends shall provide notice to the Law Library of the resignation of a Trustee-appointed Director. If the resignation is effective at a future time, a successor may be designated in accordance with the procedure set forth below in this paragraph to take office when the resignation becomes effective. Unless the California Attorney General is first notified, no director Director may resign when the corporation Friends would then be left without a duly elected director Director in charge of its affairs. All vacancies on the boardBoard shall be filled by the Board of Trustees or the existing directors Directors of the corporationFriends, as the case may be and depending on whether the vacancy arose from a slot previously appointed by the Board of Trustees or the existing directors Directors of the corporation. In the event that the Board of Trustees does not fill vacancies to which it is entitled within a reasonable period of time, the existing directors of time at temporary board Board resolution (lasting for not more than 90 days) resetting the authorized number of boardBoard members so that the actual number of boardBoard members constitutes the authorized number. If at the end of such period the Board of Trustees has not acted, then the remaining board members shall make the determination whether to change the authorized number of board members or to fill such vacancies themselves. No reduction of the authorized number of directors Directors shall have the effect of removing any director Director before that director's Director's term of office expires.

Section 5. <u>Meetings</u>. The Board of Directors shall hold an annual meeting on the third -Wednesday of -September of each year for the purpose of seating <u>directorsDirectors</u>, electing officers of <u>the corporationFriends</u>, and for the transaction of other business. <u>Notice of the annual meeting shall be given in the manner set forth below.</u>, or at such time as the <u>Board of Directors determines</u>. Other regular meetings shall be held at such times as are fixed by the Board of Directors. -Such regular meetings may be held without notice. Meetings may be held at any place designated by -the <u>chairperson of the boardBoard chair</u>, or, if not designated, at the principal office of <u>the corporationFriends</u>. Special meetings shall be held at any place designated in the notice of the meeting or, if not stated in the notice or if there is no notice, at the principal office of <u>the corporation. Friends</u>. Notwithstanding the above, any meeting may be held at any place consented to in writing (including via e-mail) by <u>all-the directors majority of the Directors</u>, either before or after the meeting. Consents shall be filed with the minutes of the meeting.

Any meeting may be held by <u>telephone</u> conference <u>telephone</u> or other communications equipment permitted by <u>the Lawlaw</u>, as long as all <u>directors Directors</u> participating in the meeting can communicate with one another and all other requirements of the <u>Lawlaw</u> are satisfied. All such <u>directors Directors</u> shall be deemed to be present in person at such meeting.

Meetings of the <u>boardBoard</u> for any purpose may be called at any time by the <u>chairpersonChair</u> of the <u>boardBoard</u>, the <u>executive directorExecutive Director</u>, the secretary, or any two (2) <u>directorsDirectors</u>. Notice of the date, time, and place of meetings shall be delivered personally to each <u>directorDirector</u> or communicated to each <u>directorDirector</u> by telephone (including a voice messaging system which records and communicates messages),

facsimile, or electronic mail at least forty-eight (48) hours prior tobefore the meeting, or communicated by telegraph, express mail service, first-class mail, or by other means of written communication, charges prepaid, addressed to the director at the director's Director's address as it is shown upon the records of the corporation Friends, deposited in the mails or given to the telegraph company or express mail company or other carrier at least four (4) days before the date of the meeting. The notice need not specify the purpose of the meeting. Notice of a meeting need not be given to any director Director who signs a waiver of notice or a consent to holding the meeting or an approval of the minutes of the meeting, whether before or after the meeting, or who attends the meeting without protesting, prior to the meeting or at its commencement, the lack of notice to such director Director. The waiver of notice or consent need not specify the purpose of the meeting. All such waivers, consents, and approvals shall be filed with the corporate records or made a part of the minutes of the meeting.

Section 6. <u>Action at a Meeting</u>. The presence of five (5) <u>directors Directors</u> at a meeting of the Board of Directors constitutes a quorum for the transaction of business, except as otherwise provided in these Bylaws. Every act done or decision made by a majority of the <u>directors Directors</u> present at a meeting duly held at which a quorum is present shall be regarded as the act of the Board of Directors, unless a greater number, or the same number after disqualifying one or more <u>directors Directors</u> from voting, is required by the Articles of Incorporation, these bylaws, or <u>the State</u> Law. Directors may not vote by proxy. A meeting at which a quorum is initially present, including an adjourned meeting, may continue to transact business notwithstanding the withdrawal of <u>directors Directors</u>, if any action taken is approved by at least a disinterested majority of the required quorum for such meeting, or such greater number as required by the Articles of Incorporation, these bylaws or the Law.

Section 7. <u>Adjourned Meeting and Notice</u>. A majority of the <u>directorsDirectors</u> present, whether or not a quorum is present, may adjourn any meeting to another time and place. If the meeting is adjourned for more than twenty-four (24) hours, notice of any adjournment to another time or place shall be given prior to the time of the adjourned meeting to the <u>directorsDirectors</u> who were not present at the time of the adjournment. Such notice may be waived in the manner provided for in Article 7, Section 5.

Section 8. <u>Action Without a Meeting</u>. The Board of Directors may take any required or permitted action without a meeting, if all the majority of the members of the board shall individually or collectively consent in writing to such action. <u>Such written consent or consents shall be filed with the minutes of the proceedings of the board.</u> Such action by written consent shall have the same force and effect as the unanimous vote of such directors <u>Directors</u>. For purposes of this section only, "all members of the <u>boardBoard</u>" does not include any "interested <u>directorsDirectors</u>" as defined in Section 5233 of the Law.

Section 9. <u>Fees and Compensation</u>. Directors and members of committees may not receive any compensation for their services as such, but may receive reasonable reimbursement of expenses incurred in the performance of their duties, including advances as provided in Article 8, Section 2, as may be fixed or determined by resolution of the Board of Directors. Directors may not be compensated for rendering services to <u>this corporationFriends</u> in any capacity other than <u>directorDirector</u>, unless such compensation is reasonable and (a) approved as provided in Article 8, Section 4, and (b) allowable under Article 8, Section 6.

ARTICLE 8: STANDARD OF CARE

Section 1. <u>General</u>. A <u>director Director</u> shall perform the duties of a <u>director Director</u>, including duties as a member of any committee of the <u>boardBoard</u> on which the <u>director Director</u> may serve, in good faith, in a manner such <u>director Director</u> believes to be in the best interest of <u>this corporation Friends</u> and with such care, including reasonable inquiry, as an ordinarily prudent person in a like situation would use under similar circumstances.

In performing the duties of a <u>director Director</u>, a <u>director Director</u> shall be entitled to rely on information, opinions, reports or statements, including financial statements and other financial data, in each case prepared or presented by:

- (a) one or more officers or employees of the corporation Friends whom the director Director believes to be reliable and competent in the matters presented,
- (b) counsel, independent accountants or other persons as to matters which the <u>director Director</u> believes to be within such person's professional or expert competence, or
- (c) a committee of the <u>boardBoard</u> upon which the <u>directorDirector</u> does not serve, as to matters within its designated authority, which committee the <u>directorDirector</u> believes to merit confidence,

so long as in any such case, the <u>director Director</u> acts in good faith, after reasonable inquiry when the need therefore is indicated by the circumstances and without knowledge that would cause such reliance to be unwarranted.

Except as provided in Article 8, Section 3, a person who performs the duties of a director Director in accordance with the above shall have no liability based upon any failure or alleged failure to discharge that person's obligations as a director Director, including, without limiting the generality of the foregoing, any actions or omissions which exceed or defeat a public or charitable purpose to which the corporation Friends, or assets held by it, are dedicated.

- Section 2. <u>Loans. This corporation Friends</u> shall not make any loan of money or property to, or guarantee the obligation of, any <u>director Director</u> or officer, unless approved by the California Attorney General; provided, however, that <u>this corporation Friends</u> may advance money to a <u>director Director</u> or officer of <u>this corporation Friends</u> or any subsidiary for expenses reasonably anticipated to be incurred in performance of the duties of such officer or <u>director Director</u> so long as such individual would be entitled to be reimbursed for such expenses absent that advance.
- Section 3. <u>Self-Dealing Transactions</u>. Except as approved in Section 4 below, the <u>boardBoard</u> shall not approve a self-dealing transaction. A self-dealing transaction is one to which <u>the corporationFriends</u> is a party and in which one or more of the <u>directorsDirectors</u> has a material financial interest or a transaction between <u>this corporationFriends</u> and any person (other than a California nonprofit public benefit corporation) in which one or more of the <u>directorsDirectors</u> is a <u>director Director</u> or between <u>this corporationFriends</u> and any person in which one or more of its <u>directorsDirectors</u> has a material financial interest. A <u>director Director</u>

shall not be deemed to have a "material financial interest" in a contract or transaction that implements a charitable program of this-corporation-Friends solely because the contract or transaction results in a benefit to a director-Director or his or her family by virtue of their membership in the class of persons intended to be benefited by the charitable program, as long as the contract or transaction is approved or authorized by the-corporation-Friends in good faith and without unjustified favoritism.

Section 4. <u>Approval</u>. The Board of Directors may approve a self-dealing transaction if the <u>boardBoard</u> determines that the transaction is in the best interests of, and is fair and reasonable to, <u>this corporationFriends</u> and, after reasonable investigation under the circumstances, determines that <u>this corporationFriends</u> could not have obtained a more advantageous arrangement with reasonable effort under the circumstances. Such determinations must be made by the <u>boardBoard</u>, in good faith, with knowledge of the material facts concerning the transaction and the <u>director's Director's</u> interest in the transaction, and by a vote of the majority of the <u>directors Directors</u> then in office, provided that a quorum is present, without counting the vote of the interested <u>director Director</u> or <u>directors Directors</u>.

Section 5. <u>Mutual Directors</u>. No contract or other transaction between the <u>corporationFriends</u> and any California nonprofit public benefit corporation of which one or more of its <u>directorsDirectors</u> are <u>directorsDirectors</u> of <u>this corporationFriends</u> is either void or voidable because such <u>directorsDirectors</u>) are present at a meeting of the <u>boardBoard</u> which authorizes, approves, or ratifies the contract or transaction if the material facts as to the transaction and as to such <u>director'sDirector's</u> other <u>directorshipDirectorship</u> are fully disclosed or known to the <u>boardBoard</u> and the <u>boardBoard</u> authorizes, approves, or ratifies the contract or transaction in good faith by a vote sufficient without counting the vote of the <u>common directorDirector(s)</u>, or if the contract or transaction is just and reasonable as to <u>the corporationFriends</u> at the time it is authorized, approved or ratified.

Section 6. Restriction on Interested Directors. Not more than forty-nine percent (49%) of the persons serving on the Board of Directors at any time may be interested persons. An interested person is (1) any person currently being compensated by the corporation Friends for services rendered to it within the previous twelve (12) months, whether as a full-time or part-time employee, independent contractor, or otherwise, excluding any reasonable compensation paid to a director Director as director Director; and (2) any brother, sister, ancestor, descendant, spouse, brother-in-law, sister-in-law, son-in-law, daughter-in-law, mother-in-law, or father-in-law of any such person. However, any violation of the provisions of this section shall not affect the validity or enforceability of any transaction entered into by the corporation Friends.

Section 7. <u>Indemnification</u>. To the fullest extent permitted by law, this corporation Friends shall indemnify its "agents", as described in Section 5238(a) of the Law, including its <u>directors Directors</u>, officers, employees, and volunteers, and including persons formerly occupying any such position, and their heirs, executors, and administrators, against all expenses, judgments, fines, settlements, and other amounts actually and reasonably incurred by them in connection with any "proceeding, " as that term is used in said Section 5238(a), and including an action by or in the right of the corporation Friends, by reason of the fact that the person is or was a person described in that Section. "Expenses" shall have the same meaning as

in said Section. Such right of indemnification shall not be deemed exclusive of any other rights to which such persons may be entitled apart from this Article 8, Section 7.

To the fullest extent permitted by law and except as otherwise determined by the boardBoard in a specific instance, expenses incurred by a person seeking indemnification in defending any "proceeding" shall be advanced by the corporationFriends before final disposition of the proceeding upon receipt by the corporationFriends of an undertaking by or on behalf of that person to repay such amount unless it is ultimately determined that the person is entitled to be indemnified by the corporationFriends for those expenses.

The corporation Friends shall have power to purchase and maintain insurance to the fullest extent permitted by law on behalf of any agent of the corporation Friends, against any liability asserted against or incurred by the agent in such capacity or arising out of the agent's status as such, or to give other indemnification to the extent permitted by law.

ARTICLE 9: COMMITTEES

- Section 1. <u>Committees of Directors</u>. The Board of Directors may, by resolution adopted by a majority of the <u>directorsDirectors</u> then in office, provided that a quorum is present, designate one or more committees to exercise all or a portion of the authority of the <u>boardBoard</u>, to the extent of the powers specifically delegated in the resolution of the <u>boardBoard</u> or in these bylaws. Each such committee shall consist of two (2) or more <u>directorsDirectors</u>, and may also include persons who are not on the <u>boardBoard</u>, to serve at the pleasure of the <u>boardBoard</u>. The <u>boardBoard</u> may designate one or more alternate members of any committee, who may replace any absent member at any meeting of the committee. The appointment of members or alternate members of a committee requires the vote of a majority of the <u>directorsDirectors</u> then in office, provided that a quorum is present. The Board of Directors may also designate one or more advisory committees that do not have the authority of the <u>boardBoard</u>. However, no committee, regardless of <u>boardBoard</u> resolution, may:
- (a) Approve any action that, under the Law, would also require the affirmative vote of the members if this were a membership corporation.
- (b) Fill vacancies on, or remove the members of, the Board of Directors or in any committee that has the authority of the boardBoard.
- (c) Fix compensation of the <u>directors Directors</u> for serving on the <u>board Board</u> or on any committee.
 - (d) Amend or repeal the Articles of Incorporation or bylaws or adopt new bylaws.
- (e) Amend or repeal any resolution of the Board of Directors that by its express terms is not so amendable or repealable.
 - (f) Appoint any other committees of the Board of Directors or their members.

- (g) Approve a plan of merger; consolidation; voluntary dissolution; bankruptcy or reorganization; or for the sale, lease, or exchange of all or substantially all of the property and assets of the corporation Friends otherwise than in the usual and regular course of its business; or revoke any such plan.
- (h) Approve any self-dealing transaction, except as provided by Section 5233 of the Law.

No committee shall bind the corporation Friends in a contract or agreement or expend corporate funds, unless authorized to do so by the Board of Directors.

- Section 2. <u>Meetings and Actions of Committees</u>. Meetings and actions of all committees shall be governed by, and held and taken in accordance with, the provisions of Article 7 of these bylaws, concerning meetings and actions of <u>directorsDirectors</u>, with such changes in the context of those bylaws as are necessary to substitute the committee and its members for the Board of Directors and its members, except that the time for regular meetings of committees may be determined either by resolution of the Board of Directors or by <u>resolution of</u> the committee <u>itself</u>. Special meetings of committees may also be called by <u>resolution of the Board of Directors the respective committees</u>. Notice of special meetings of committees shall also be given to any and all alternate members, who shall have the right to attend all meetings of the committee. <u>Minutes shall be kept of each meeting of any committee and shall be filed with the corporate records</u>. The Board of Directors may adopt rules not inconsistent with the provisions of these bylaws for the government of any committee.
- Section 3. Executive Committee. Pursuant to Article 9, Section 1, the board may appoint an Executive Committee composed of three (3) or more directors, one of whom shall be the chairperson of the board, to serve as the Executive Committee of the board. The Executive Committee, unless limited in a resolution of the board, shall have and may exercise all the authority of the boardBoard in the management of the business and affairs of the corporationFriends between meetings of the boardBoard; provided, however, that the Executive Committee shall not have the authority of the boardBoard in reference to those matters enumerated in Article 9, Section 1. The secretary of, except the corporationExecutive Committee shall send to each director a summary report of also have the business conducted at authority to appoint any meeting of the Executive Committee other committees of the Board of Directors or their members.

The Executive Committee shall be composed of the Board officers and also include the Chair of the Governance and Board Excellence Committee. All members of the Executive Committee shall be voting members of the Board. The Executive Director may be present at an Executive Committee meeting at the invitation of the one or more Board officers, but shall not have a vote at such meetings.

Regular meetings of the Executive Committee shall be held at least four (4) times per year. The presence of a majority of the members of the Executive Committee then serving in office shall be necessary and sufficient to constitute a quorum, and the act of a majority of the members of the Executive Committee present at a meeting of the Executive Committee shall be the act of the Executive Committee. The Executive Committee shall keep full and fair records and

accounts of its proceedings and transactions. All actions by the Executive Committee shall be reported to the Board of Directors at its next meeting.

Section 4. Governance and Board Excellence Committee.

The Governance and Board Excellence Committee (the "Committee") shall be comprised of a chair and two to four Directors. The Chair of the Governance and Board Excellence Committee shall be the Vice-Chair of the Board. The Committee reports directly to the Board of Directors.

The Committee shall develop, and ensure appropriate implementation of the Board's goals. The Committee will offer orientations and onboarding strategies to impart Director duties, review the Friends' mission statement, and emphasize the appropriate respect of diversity, equity, and inclusion, among other subjects.

The Committee shall periodically review the defined and adopted mission and vision statements of the organization and determine whether they are consistent across documents and activities. It shall further review the governing documents of the organization and determine whether they are consistent with applicable laws and actual or desired organizational practices and suggest amendments to such governing documents as necessary.

The Committee shall locate and recruit potential Directors and shall direct enrichment activities for the Board. The Committee shall establish Board composition priorities, meet with potential Directors to explain the work of Friends, and identify strengths of candidates for the Board of Directors. Meetings of the Committee shall be held as necessary, approximately two (2) or more times per year. The objectives of the Committee also include the following:

- Nomination of the Officers of the Board
- Development of criteria for selection of Directors
- o Recommendations for nomination/re-nomination to Board membership
- Development of a strategy for cultivation of new Directors
- o Development of tools for evaluation of overall Board performance
- Development of tools for individual Director's self-assessment
- Implementation of programs to promote the effectiveness of existing and new Directors through communication, training and orientation activities

Section 5. Committees. Other committees may be created to conduct the work of the Friends, either specifically to enhance the function of the Board or to work on raising additional funds for the Law Library, or for other purposes as determined by the Board and the Friends' Executive Director.

Section 6. Committee Meetings. Unless otherwise provided for in these bylaws, a majority of the members serving on a committee constitutes a quorum of the committee for the meeting of the committee and the vote of a simple majority of those present at a meeting at which a quorum is present constitutes an action of the committee. Each committee shall

determine and schedule the number of regular meetings it will hold each year in connection with the Executive Director or the Chair.

ARTICLE 10: OFFICERS

Section 1. Officers. The officers of the corporation Friends shall consist of an executive director, secretarya Chair, Vice Chair Secretary and treasurer Treasurer and such other officers as the board Board may designate by resolution; provided, that at no time shall any Board of Trustees members or Law Library officers or employees serve concurrently as officers or employees of this corporation. Friends. The same person may hold any number of offices, except that neither the secretary nor the treasurer may serve concurrently as the executive director or chairperson Chair (or president, if there is a president position created). The Executive Director Chair may, however, assist the Secretary secretary and Treasurer with the performance of their duties. In addition to the duties specified in this Article 10, officers shall perform all other duties customarily incident to their office and such other duties as may be required by law, by the Articles of Incorporation, or by these bylaws, subject to control of the Board of Directors, and shall perform such additional duties as the Board of Directors shall from time—to—time assign.

The officers shall be chosen by the boardBoard at its annual meeting, and shall serve at the pleasure of the board, Board, for a term of two (2) years which can be renewed and subject to the rights, if any, of any officer under any contract of employment. Without prejudice to any rights of an officer under any contract of employment, any officer may be removed with or without cause by the boardBoard. Any officer may resign at any time by giving written notice to the Board of Directors, the chairpersonChair of the boardBoard, the executive director Executive Director, or the secretary of the corporation Friends, without prejudice, however, to the rights, if any, of the corporation Friends under any contract to which such officer is a party. Any resignation shall take effect on the date of the receipt of such notice or at any later time specified in the resignation; and, unless otherwise specified in the resignation, the acceptance of the resignation shall not be necessary to make it effective. A vacancy in any office because of death, resignation, removal, disqualification, or any other cause shall be filled in the manner prescribed in these bylaws for regular appointments to that office, except that the Board of Directors may choose a new officer to fill a vacancy as soon as possible after the vacancy occurs, and need not wait until the annual meeting. The compensation, if any, of the officers shall be fixed or determined by resolution of the Board of Directors.

Section 2. <u>ChairpersonChair of the Board</u>. The <u>chairpersonChair</u> of the <u>boardBoard</u> (who may also be referred to as the "president" of the <u>boardBoard</u>, if the <u>boardBoard</u> so designates) shall, when present, preside at all meetings of the Board of Directors and Executive Committee. The <u>chairpersonChair</u> is authorized to execute in the name of <u>the corporationFriends</u> all contracts and other documents authorized either generally or specifically by the <u>boardBoard</u> to be executed by <u>the corporationFriends</u>, except when by law the signature of the <u>executive directorExecutive Director</u> is required.

- Section 3. <u>Vice ChairpersonChair of the Board</u>. The <u>vice chairpersonVice Chair</u> (who may also be referred to as the "vice-president" of the <u>boardBoard</u>, if the <u>boardBoard</u> so designates) shall, in the absence of the <u>chairpersonChair</u>, or in the event of his or her inability or refusal to act, perform all the duties of the <u>chairpersonChair</u>, and when so acting shall have all the powers of, and be subject to all the restrictions on, the <u>chairpersonChair</u>. The <u>Vice Chair shall also chair the Governance and Board Excellence Committee</u>, as set forth in Article 9, Section 4.
- Section 4. Executive Director. Subject to the control, advice and consent of the Board of Directors, the Executive Director shall, in general, supervise and conduct the activities and operations of the corporation Friends, shall keep the Board of Directors fully informed and shall freely consult with them concerning the activities of the corporation Friends, and shall see that all orders and resolutions of the board Board are carried into effect. Where appropriate, the Board of Directors shall place the Executive Director under a contract of employment. The Executive Director shall be empowered to act, speak for, or otherwise represent the corporationFriends between meetings of the boardBoard. The Executive Director shall be responsible for the hiring and firing of all personnel, and shall be responsible for keeping the board Board informed at all times of staff performance and for implementing any personnel policies adopted by the board Board. The Executive Director is authorized to contract, receive, deposit, disburse, and account for funds of the corporation Friends; to execute in the name of the corporation Friends all contracts and other documents authorized either generally or specifically by the boardBoard to be executed by the corporationFriends; and to negotiate all material business transactions of the corporation. Friends. Unless otherwise specified by board Board resolution, the Executive Director shall serve the functions of chief executive officer of the corporation. Friends. Additionally, the Executive Director shall have the right to be present at all boardBoard meetings of this corporationFriends; provided, that the Executive Director shall not have the right to vote in any such meetings.
- Section 5. <u>Secretary</u>. The secretary, or his or her designee, shall be custodian of all records and documents of the <u>corporation which are to be kept at the principal office of the corporation Friends</u>, shall act as secretary of all the meetings of the Board of Directors, and shall keep the minutes of all such meetings in <u>books proposed for that purpose</u>. <u>He. The secretary, or <u>shehis or her designee, also</u> shall <u>attend to the giving and servingtake minutes</u> of all <u>notices business conducted at the meetings</u> of the <u>corporation Executive Committee</u>, and <u>shall see that be prepared, at the <u>seal Chair's request, to send each Director</u> of the <u>corporation is affixed to all documents, the execution Board</u> of <u>which on behalf Directors, a summary report</u> of the <u>corporation under its seal is duly authorized in accordance with the provisions minutes</u> of <u>these bylaws.such meetings</u>.</u></u>
- Section 6. <u>Treasurer</u>. The treasurer, or his or her designee, shall keep and maintain, or cause to be kept and maintained, adequate and correct accounts of the properties and business transactions of the corporation Friends, including accounts of its assets, liabilities, receipts, disbursements, gains, losses, capital, retained earnings, and other matters customarily included in financial statements.

The treasurer shall deposit or cause to be deposited all moneys and other valuables in the name and to the credit of the corporationFriends with such depositories as may be designated by the Board of Directors. The treasurer shall disburse or cause to be disbursed the funds of the corporationFriends as may be ordered by the Board of Directors, and shall render to the chairperson, executive director, directorsChair, Executive Director, Directors, whenever they request it, an account of all of the treasurer's transactions as treasurer and of the financial condition of the corporationFriends.

If required by the Board of Directors, the treasurer shall give the corporation Friends a bond in the amount and with the surety or sureties specified by the board For faithful performance of the duties of the treasurer's office and for restoration to the corporation Friends of all its books, papers, vouchers, money and other property of every kind in the treasurer's possession or under the treasurer's control on the treasurer's death, resignation, retirement, or removal from office. The corporation Friends shall pay the cost of such bond.

ARTICLE 11: EXECUTION OF CORPORATE INSTRUMENTS

Section 1. <u>Execution of Corporate Instruments</u>. The Board of Directors may, in its discretion, determine the method and designate the signatory officer or officers or other person or persons, to execute any corporate instrument or document, or to sign the corporate name without limitation, except when otherwise provided by law, and such execution or signature shall be binding upon the corporationFriends.

Unless otherwise specifically determined by the Board of Directors or otherwise required by law, formal contracts of the corporation Friends, promissory notes, deeds of trust, mortgages, and other evidences of indebtedness of the corporation Friends, and other corporate instruments or documents, memberships in other corporations, and certificates of shares of stock owned by the corporation Friends, shall be executed, signed, or endorsed by the chairperson Chair of the Board, Vice Chair of the board, vice chairperson of the board Board or the executive director Executive Director and by the secretary or treasurer or any assistant secretary or assistant treasurer.

All checks and drafts drawn on banks or other depositories on funds to the credit of the corporation Friends, or in special accounts of the corporation Friends, shall be signed by such person or persons as the Board of Directors shall authorize to do so.

Section 2. <u>Loans and Contracts</u>. No loans or advances shall be contracted on behalf of the corporation Friends and no note or other evidence of indebtedness shall be issued in its name unless and except as the specific transaction is authorized by the Board of Directors. Without the express and specific authorization of the <u>boardBoard</u>, no officer or other agent of the corporation Friends may enter into any contract or execute and deliver any instrument in the name of and on behalf of the corporation Friends.

ARTICLE 12: ARTICLE 12: RECORDS AND REPORTS

Section 1. <u>Maintenance and Inspection of Articles and Bylaws</u>. The corporationFriends shall keep at its principal office the original or a copy of its Articles of

Incorporation and bylaws as amended to date, which shall be open to inspection by the directors Directors at all reasonable times during office hours.

- Section 2. <u>Maintenance and Inspection of Federal Tax Exemption Application and Annual Information Returns</u>. <u>The corporationFriends</u> shall keep at its principal office a copy of its federal tax exemption application and its annual information returns for three years from their date of filing, which shall be open to public inspection and copying to the extent required by law.
- Section 3. Maintenance and Inspection of Other Corporate Records. The corporationFriends shall keep adequate and correct books and records of accounts, and written minutes of the proceedings of the boardBoard and committees of the boardBoard. All such records shall be kept at such place or places designated by the Board of Directors, or, in the absence of such designation, at the principal office of the corporation.Friends. The minutes shall be kept in written or typed form, and other books and records shall be kept either in written or typed form or in any other form capable of being converted into written, typed, or printed form. Upon leaving office, each officer, employee, or agent of the corporation shall turn over to his or her successor or the chairpersonChair or executive directorExecutive Director, in good order, such corporate monies, books, records, minutes, lists, documents, contracts or other property of the corporationFriends as have been in the custody of such officer, employee, or agent during his or her term of office.

Every <u>director Director</u> shall have the absolute right at any reasonable time to inspect all books, records, and documents of every kind and the physical properties of <u>the corporation Friends</u> and each of its subsidiary corporations. The inspection may be made in person or by an agent or attorney, and shall include the right to copy and make extracts of documents.

- Section 4. <u>Annual Report; Statement of Certain Transactions</u>. The <u>boardBoard</u> shall cause an annual report to be sent to all <u>directorsDirectors</u> of <u>the corporationFriends</u> within 120 days after the end of the corporation's fiscal year containing the following information:
- (a) The assets and liabilities, including the trust funds, of this corporation Friends at the end of the fiscal year;
- (b) The principal changes in assets and liabilities, including trust funds, during the fiscal year;
- (c) The revenues or receipts of this corporation Friends, both unrestricted and restricted for particular purposes, for the fiscal year;
- (d) The expenses or disbursements of this corporation Friends for both general and restricted purposes during the fiscal year; and
- (e) The information required by Section 6322 of the Law concerning certain self-dealing transactions involving more than \$50,000 or indemnifications involving more than \$10,000 which took place during the fiscal year.

The report shall be accompanied by any pertinent report of independent accountants, or, if there is no such report, the certificate of an authorized officer of the corporation Friends that such statements were prepared without audit from the books and records of the corporation Friends.

ARTICLE 13: FISCAL YEAR

The fiscal year for this corporation Friends shall begin on April July 1 and shall end on March 31st June 30th.

ARTICLE 14: AMENDMENTS AND REVISIONS

These bylaws may be adopted, amended or repealed by the vote of a majority of the directors Directors then in office. Such action is authorized only at a duly called and held meeting of the Board of Directors for which written notice of such meeting, setting forth the proposed bylaw revisions with explanations therefore, is given in accordance with these bylaws, unless such notice is waived in accordance with these bylaws. If any provision of these bylaws requires the vote of a larger proportion of the boardBoard than is otherwise required by law, that provision may not be altered, amended, or repealed except by that greater vote. Any adoption, amendment or repeal of these bylaws that adversely affects the rights granted to the Board of Trustees or the existing directors Directors of the corporationFriends under the bylaws, including without limitation the right to appoint directorsDirectors, to fill vacancies on the Board of Directors, and the rights granted by this Article 14, shall also require the approval of the Board of Trustees.

ARTICLE 15: CORPORATE SEAL

The Board of Directors may adopt, use, and alter a corporate seal. The seal shall be kept at the principal office of the corporation. Friends. Failure to affix the seal to any corporate instrument, however, shall not affect the validity of that instrument.

ARTICLE 16: CONSTRUCTION AND DEFINITIONS

Unless the context otherwise requires, the general provisions, rules of construction, and definitions contained in the California Nonprofit Corporation Law as amended from time to time shall govern the construction of these bylaws. Without limiting the generality of the foregoing, the masculine gender includes the feminine and neuter, the singular number includes the plural and the plural number includes the singular, and the term "person" includes a corporation as well as a natural person. If any competent court of law shall deem any portion of these bylaws invalid or inoperative, then so far as is reasonable and possible (i)1) the remainder of these bylaws shall be considered valid and operative, and (ii2) effect shall be given to the intent manifested by the portion deemed invalid or inoperative.

AMENDED AND RESTATED BYLAWS

OF

FRIENDS OF THE LOS ANGELES COUNTY LAW LIBRARY (a California Nonprofit Public Benefit Corporation)

ARTICLE 1: NAME

The name of the corporation is Friends of the Los Angeles County Law Library ("Friends").

ARTICLE 2: PURPOSES

Friends has been formed for charitable purposes. The creation of Friends is not intended to supersede state policy regarding funding of county law libraries as provided under California Business and Professions Code Section 6300 et al., (or any successor section to that code, if applicable). Friends has been formed to raise funds (generally from the private sector) to support the collections, staff, facilities, and programs and services of the Los Angeles County Law Library ("Law Library"); funds raised by the corporation, except those retained for Friends' reasonable administrative and operating expenses, shall be directed towards the Law Library in furtherance of Friends' purpose to support the Law Library's activities. In addition, Friends is formed for the purposes of performing all things incidental to, or appropriate in, achieving the foregoing specific and primary purposes. Friends shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of its primary charitable purposes.

Friends shall hold and may exercise all such powers as may be conferred upon a nonprofit corporation by the laws of the State of California and as may be necessary or expedient for the administration of the affairs and attainment of the purposes of the corporation, provided, however, that Friends shall not engage in activities that are not permitted to be carried on by a corporation exempt under Section 501(c)(3) of the Internal Revenue Code. Additionally, Friends' activities shall be limited in the following ways:

- 1. Friends shall act as a separate corporation in a fundraising capacity to the Law Library Board of Trustees (the "Board of Trustees").
- 2. Friends is not the agent of the Law Library or of the Board of Trustees and shall have no right or authority to bind or contract for the Law Library or the Board of Trustees. Friends' support of the Law Library shall not in any way enable it to control the policies, programs or services offered by the Law Library. The Board of Trustees shall have no right or authority to bind or contract for the Friends, and their primary role shall be as designated in Article 7, Section 3.

ARTICLE 3: PRINCIPAL OFFICE

The initial principal office of Friends shall be located in the City of Los Angeles, County of Los Angeles, State of California. Friends' Board of Directors may at any time, or from time to time, change the location of the principal office from one location to another within said city and county.

The Board of Directors may at any time establish branch offices at any place where Friends is qualified to do business.

ARTICLE 4: NONPARTISAN ACTIVITIES

Friends has been formed under California Nonprofit Public Benefit Corporation Law, Sections 5110-6910 and any successor sections, as applicable (the "Law") for the charitable purposes described above, and it shall be nonprofit and nonpartisan. Friends shall not participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE 5: DEDICATION OF ASSETS

The properties and assets of this nonprofit corporation are irrevocably dedicated to charitable purposes. No part of the net earnings, properties, or assets of Friends, on dissolution or otherwise, shall inure to the benefit of any private person or individual, or any member, Director, or officer of Friends. On liquidation or dissolution, all remaining properties and assets of Friends shall be distributed and paid over to another organization dedicated to charitable purposes that has established its tax-exempt status under Internal Revenue Code Section 501(c)(3).

ARTICLE 6: MEMBERSHIP

Friends shall not have Members within the meaning of Section 5056 of the California Corporations Code. Nothing contained in this Article 6 shall be construed to limit the right of Friends to refer to persons associated with Friends as "members" even though such persons are not members, as defined by the Corporations Code, and no such reference shall constitute anyone being a Member, within the meaning of Section 5056 of the Corporations Code. Upon designation of criteria for advisory membership by the Board of Directors, Friends may have advisory members who are not members within the meaning of Section 5056 of the Corporations Code.

ARTICLE 7: BOARD OF DIRECTORS

Section 1. <u>Powers</u>. Subject to the provisions and limitations of the Law and any other applicable laws, the business and affairs of Friends shall be managed, and all corporate powers shall be exercised, by or under the direction of the Board of Directors. The Board of Directors may delegate the management of the day-to-day operation of the business of Friends to a management company, employed staff and/or consultants, committees (however composed), or other persons, provided that the activities and affairs of Friends shall be managed and all corporate powers shall be exercised under the ultimate direction of the Board of Directors.

Section 2. <u>Number of Directors</u>. The authorized number of Directors shall consist of not less than 9 (nine) positions nor more than 25 (twenty-five) positions, the exact number of Directors to be fixed, within the limits specified in this Article 7 Section 2, by resolution of the Board.

Section 3. <u>Designation and Term of Office of Directors</u>. The Board of Trustees shall appoint a majority of Directors of Friends; provided, that at no time shall any Board of Trustees members or Law Library officers or employees serve concurrently on the Board of Friends. The remaining Directors of Friends shall be appointed by the existing Directors of Friends as vacancies occur.

The term of office of each Director shall be two (2) years.

Except as otherwise provided in these Bylaws, each Director, including a Director appointed to fill a vacancy, shall hold office until expiration of the term for which appointed and until a successor has been appointed and qualified. Directors may serve consecutive terms so long as Directors appointed by the Board are proposed by the majority vote of the Governance and Board Excellence Committee and then approved by the Board.

Section 3.1. <u>Board Composition</u>. Friends' Board members shall collectively represent a diversity (e.g., race, ethnicity, and gender) of backgrounds and include members of the legal and business communities at-large and/or have demonstrated commitment to the Law Library as patrons, funders or supporters thereof. Every Director shall also actively serve on a Board committee to be determined by the Director and the Governance and Board Excellence Committee.

Section 3.2 Emeritus Directors

From time to time, and in the exercise of its sole discretion, the Board shall have the authority to appoint or remove as Director Emeritus one or more individuals from among current or former Directors, whom the Board shall determine are qualified by virtue of their eminent standing in the community. A Director Emeritus may receive upon request any notices, reports and/or publications sent to members of the Board, and may attend Board meetings as provided in this Section, except for meetings held in executive session. If a Director Emeritus attends a meeting, the Director Emeritus shall not count for the purposes of establishing a quorum and shall not have the right to vote, but shall give the Board the benefit of his or her knowledge and experience in matters affecting the Law Library or the Friends. Directors Emeritus do not count toward the authorized number of Directors set forth in Article 7 Section 2.

Section 4. <u>Vacancies</u>. A vacancy on the Board shall exist upon: (a) the death, resignation, or removal of any Director; (b) the declaration by resolution of the Board of a vacancy in the office of a Director who has been declared of unsound mind by a final order of court, convicted of a felony, or found by final order or judgment of any court to have breached a duty under Sections 5230-5239 of the Law dealing with standards of conduct for a Director, (c)

an increase in the authorized number of Directors; or (d) the failure of the Board of Trustees or the Friends of the Los Angeles County Law Library, at any annual meeting or otherwise, to appoint the full authorized number of Directors.

The Board of Directors, by affirmative vote of a majority of the Directors then in office, may remove any Director with or without cause at any regular or special meeting; provided that the Director to be removed and the Board of Trustees have been notified in writing in the manner set forth in Article 7, Section 5 that such action would be considered at the meeting.

Except as provided in this paragraph, any Director may resign effective upon giving written notice to the Chair of the Board, the Executive Director, the secretary, or the Board of Directors, unless the notice specifies a later time for the effectiveness of the resignation. Friends shall provide notice to the Law Library of the resignation of a Trustee-appointed Director. If the resignation is effective at a future time, a successor may be designated in accordance with the procedure set forth below in this paragraph to take office when the resignation becomes effective. Unless the California Attorney General is first notified, no Director may resign when Friends would then be left without a duly elected Director in charge of its affairs. All vacancies on the Board shall be filled by the Board of Trustees or the existing Directors of Friends, as the case may be and depending on whether the vacancy arose from a slot previously appointed by the Board of Trustees or the existing Directors of the corporation. In the event that the Board of Trustees does not fill vacancies to which it is entitled within a reasonable period of time, the existing Directors shall adopt a temporary Board resolution (lasting for not more than 90 days) resetting the authorized number of Board members so that the actual number of Board members constitutes the authorized number. If at the end of such period the Board of Trustees has not acted, then the remaining Board members shall make the determination whether to change the authorized number of Board members or to fill such vacancies themselves. No reduction of the authorized number of Directors shall have the effect of removing any Director before that Director's term of office expires.

Section 5. Meetings. The Board of Directors shall hold an annual meeting on the third Wednesday of September of each year for the purpose of seating Directors, electing officers of Friends, and for the transaction of other business, or at such time as the Board of Directors determines. Other regular meetings shall be held at such times as are fixed by the Board of Directors. Such regular meetings may be held without notice. Meetings may be held at any place designated by the Board chair, or, if not designated, at the principal office of Friends. Special meetings shall be held at any place designated in the notice of the meeting or, if not stated in the notice or if there is no notice, at the principal office of Friends. Notwithstanding the above, any meeting may be held at any place consented to in writing (including via e-mail) by the majority of the Directors, either before or after the meeting. Consents shall be filed with the minutes of the meeting.

Any meeting may be held by telephone conference or other communications equipment permitted by law, as long as all Directors participating in the meeting can communicate with one another and all other requirements of the law are satisfied. All such Directors shall be deemed to be present in person at such meeting.

Meetings of the Board for any purpose may be called at any time by the Chair of the Board, the Executive Director, the secretary, or any two (2) Directors. Notice of the date, time, and place of meetings shall be delivered personally to each Director or communicated to each Director by telephone (including a voice messaging system which records and communicates messages), facsimile, or electronic mail at least forty-eight (48) hours before the meeting, or communicated by express mail service, first-class mail, or by other means of written communication, charges prepaid, addressed to the Director at the Director's address as it is shown upon the records of Friends, deposited in the mails or given to the express mail company or other carrier at least four (4) days before the date of the meeting. The notice need not specify the purpose of the meeting. Notice of a meeting need not be given to any Director who signs a waiver of notice or a consent to holding the meeting or an approval of the minutes of the meeting, whether before or after the meeting, or who attends the meeting without protesting, prior to the meeting or at its commencement, the lack of notice to such Director. The waiver of notice or consent need not specify the purpose of the meeting. All such waivers, consents, and approvals shall be filed with the corporate records or made a part of the minutes of the meeting.

- Section 6. <u>Action at a Meeting</u>. The presence of five (5) Directors at a meeting of the Board of Directors constitutes a quorum for the transaction of business, except as otherwise provided in these Bylaws. Every act done or decision made by a majority of the Directors present at a meeting duly held at which a quorum is present shall be regarded as the act of the Board of Directors, unless a greater number, or the same number after disqualifying one or more Directors from voting, is required by the Articles of Incorporation, these bylaws, or State Law. Directors may not vote by proxy. A meeting at which a quorum is initially present, including an adjourned meeting, may continue to transact business notwithstanding the withdrawal of Directors, if any action taken is approved by at least a disinterested majority of the required quorum for such meeting, or such greater number as required by the Articles of Incorporation, these bylaws or the Law.
- Section 7. <u>Adjourned Meeting and Notice</u>. A majority of the Directors present, whether or not a quorum is present, may adjourn any meeting to another time and place. If the meeting is adjourned for more than twenty-four (24) hours, notice of any adjournment to another time or place shall be given prior to the time of the adjourned meeting to the Directors who were not present at the time of the adjournment. Such notice may be waived in the manner provided for in Article 7. Section 5.
- Section 8. <u>Action Without a Meeting</u>. The Board of Directors may take any required or permitted action without a meeting, if the majority of the members of the Board shall individually or collectively consent in writing to such action. Such action by written consent shall have the same force and effect as the unanimous vote of such Directors. For purposes of this section only, "all members of the Board" does not include any "interested Directors" as defined in Section 5233 of the Law.
- Section 9. <u>Fees and Compensation</u>. Directors and members of committees may not receive any compensation for their services as such, but may receive reasonable reimbursement of expenses incurred in the performance of their duties, including advances as provided in Article 8, Section 2, as may be fixed or determined by resolution of the Board of Directors. Directors may not be compensated for rendering services to Friends in any capacity other than

Director, unless such compensation is reasonable and (a) approved as provided in Article 8, Section 4, and (b) allowable under Article 8, Section 6.

ARTICLE 8: STANDARD OF CARE

Section 1. <u>General</u>. A Director shall perform the duties of a Director, including duties as a member of any committee of the Board on which the Director may serve, in good faith, in a manner such Director believes to be in the best interest of Friends and with such care, including reasonable inquiry, as an ordinarily prudent person in a like situation would use under similar circumstances.

In performing the duties of a Director, a Director shall be entitled to rely on information, opinions, reports or statements, including financial statements and other financial data, in each case prepared or presented by:

- (a) one or more officers or employees of Friends whom the Director believes to be reliable and competent in the matters presented,
- (b) counsel, independent accountants or other persons as to matters which the Director believes to be within such person's professional or expert competence, or
- (c) a committee of the Board upon which the Director does not serve, as to matters within its designated authority, which committee the Director believes to merit confidence,

so long as in any such case, the Director acts in good faith, after reasonable inquiry when the need therefore is indicated by the circumstances and without knowledge that would cause such reliance to be unwarranted.

Except as provided in Article 8, Section 3, a person who performs the duties of a Director in accordance with the above shall have no liability based upon any failure or alleged failure to discharge that person's obligations as a Director, including, without limiting the generality of the foregoing, any actions or omissions which exceed or defeat a public or charitable purpose to which Friends, or assets held by it, are dedicated.

- Section 2. <u>Loans</u>. Friends shall not make any loan of money or property to, or guarantee the obligation of, any Director or officer, unless approved by the California Attorney General; provided, however, that Friends may advance money to a Director or officer of Friends or any subsidiary for expenses reasonably anticipated to be incurred in performance of the duties of such officer or Director so long as such individual would be entitled to be reimbursed for such expenses absent that advance.
- Section 3. <u>Self-Dealing Transactions</u>. Except as approved in Section 4 below, the Board shall not approve a self-dealing transaction. A self-dealing transaction is one to which Friends is a party and in which one or more of the Directors has a material financial interest or a transaction between Friends and any person (other than a California nonprofit public benefit corporation) in which one or more of the Directors is a Director or between Friends and any person in which one or more of its Directors has a material financial interest. A Director shall not be deemed to have a "material financial interest" in a contract or transaction that implements

a charitable program of Friends solely because the contract or transaction results in a benefit to a Director or his or her family by virtue of their membership in the class of persons intended to be benefited by the charitable program, as long as the contract or transaction is approved or authorized by Friends in good faith and without unjustified favoritism.

- Section 4. <u>Approval</u>. The Board of Directors may approve a self-dealing transaction if the Board determines that the transaction is in the best interests of, and is fair and reasonable to, Friends and, after reasonable investigation under the circumstances, determines that Friends could not have obtained a more advantageous arrangement with reasonable effort under the circumstances. Such determinations must be made by the Board, in good faith, with knowledge of the material facts concerning the transaction and the Director's interest in the transaction, and by a vote of the majority of the Directors then in office, provided that a quorum is present, without counting the vote of the interested Director or Directors.
- Section 5. <u>Mutual Directors</u>. No contract or other transaction between Friends and any California nonprofit public benefit corporation of which one or more of its Directors are Directors of Friends is either void or voidable because such Directors) are present at a meeting of the Board which authorizes, approves, or ratifies the contract or transaction if the material facts as to the transaction and as to such Director's other Directorship are fully disclosed or known to the Board and the Board authorizes, approves, or ratifies the contract or transaction in good faith by a vote sufficient without counting the vote of the Director(s), or if the contract or transaction is just and reasonable as to Friends at the time it is authorized, approved or ratified.
- Section 6. Restriction on Interested Directors. Not more than forty-nine percent (49%) of the persons serving on the Board of Directors at any time may be interested persons. An interested person is (1) any person currently being compensated by Friends for services rendered to it within the previous twelve (12) months, whether as a full-time or part-time employee, independent contractor, or otherwise, excluding any reasonable compensation paid to a Director as Director; and (2) any brother, sister, ancestor, descendant, spouse, brother-in-law, sister-in-law, son-in-law, daughter-in-law, mother-in-law, or father-in-law of any such person. However, any violation of the provisions of this section shall not affect the validity or enforceability of any transaction entered into by Friends.
- Section 7. <u>Indemnification</u>. To the fullest extent permitted by law, Friends shall indemnify its "agents", as described in Section 5238(a) of the Law, including its Directors, officers, employees, and volunteers, and including persons formerly occupying any such position, and their heirs, executors, and administrators, against all expenses, judgments, fines, settlements, and other amounts actually and reasonably incurred by them in connection with any "proceeding," as that term is used in said Section 5238(a), and including an action by or in the right of Friends, by reason of the fact that the person is or was a person described in that Section. "Expenses" shall have the same meaning as in said Section. Such right of indemnification shall not be deemed exclusive of any other rights to which such persons may be entitled apart from this Article 8, Section 7.

To the fullest extent permitted by law and except as otherwise determined by the Board in a specific instance, expenses incurred by a person seeking indemnification in defending any "proceeding" shall be advanced by Friends before final disposition of the proceeding upon

receipt by Friends of an undertaking by or on behalf of that person to repay such amount unless it is ultimately determined that the person is entitled to be indemnified by Friends for those expenses.

Friends shall have power to purchase and maintain insurance to the fullest extent permitted by law on behalf of any agent of Friends, against any liability asserted against or incurred by the agent in such capacity or arising out of the agent's status as such, or to give other indemnification to the extent permitted by law.

ARTICLE 9: COMMITTEES

- Section 1. <u>Committees of Directors</u>. The Board of Directors may, by resolution adopted by a majority of the Directors then in office, provided that a quorum is present, designate one or more committees to exercise all or a portion of the authority of the Board, to the extent of the powers specifically delegated in the resolution of the Board or in these bylaws. Each such committee shall consist of two (2) or more Directors, and may also include persons who are not on the Board, to serve at the pleasure of the Board. The Board may designate one or more alternate members of any committee, who may replace any absent member at any meeting of the committee. The appointment of members or alternate members of a committee requires the vote of a majority of the Directors then in office, provided that a quorum is present. The Board of Directors may also designate one or more advisory committees that do not have the authority of the Board. However, no committee, regardless of Board resolution, may:
- (a) Approve any action that, under the Law, would also require the affirmative vote of the members if this were a membership corporation.
- (b) Fill vacancies on, or remove the members of, the Board of Directors or in any committee that has the authority of the Board.
 - (c) Fix compensation of the Directors for serving on the Board or on any committee.
 - (d) Amend or repeal the Articles of Incorporation or bylaws or adopt new bylaws.
- (e) Amend or repeal any resolution of the Board of Directors that by its express terms is not so amendable or repealable.
 - (f) Appoint any other committees of the Board of Directors or their members.
- (g) Approve a plan of merger; consolidation; voluntary dissolution; bankruptcy or reorganization; or for the sale, lease, or exchange of all or substantially all of the property and assets of Friends otherwise than in the usual and regular course of its business; or revoke any such plan.
- (h) Approve any self-dealing transaction, except as provided by Section 5233 of the Law.

No committee shall bind Friends in a contract or agreement or expend corporate funds, unless authorized to do so by the Board of Directors.

Section 2. <u>Meetings and Actions of Committees</u>. Meetings and actions of all committees shall be governed by, and held and taken in accordance with, the provisions of Article 7 of these bylaws, concerning meetings and actions of Directors, with such changes in the context of those bylaws as are necessary to substitute the committee and its members for the Board of Directors and its members, except that the time for regular meetings of committees may be determined either by resolution of the Board of Directors or by the committee itself. Special meetings of committees may also be called by the respective committees. Notice of special meetings of committees shall also be given to any and all alternate members, who shall have the right to attend all meetings of the committee. The Board of Directors may adopt rules not inconsistent with the provisions of these bylaws for the government of any committee.

Section 3. <u>Executive Committee</u>. The Executive Committee shall have and may exercise all the authority of the Board in the management of the business and affairs of Friends between meetings of the Board; provided, however, that the Executive Committee shall not have the authority of the Board in reference to those matters enumerated in Article 9, Section 1, except the Executive Committee shall also have the authority to appoint any other committees of the Board of Directors or their members.

The Executive Committee shall be composed of the Board officers and also include the Chair of the Governance and Board Excellence Committee. All members of the Executive Committee shall be voting members of the Board. The Executive Director may be present at an Executive Committee meeting at the invitation of the one or more Board officers, but shall not have a vote at such meetings.

Regular meetings of the Executive Committee shall be held at least four (4) times per year. The presence of a majority of the members of the Executive Committee then serving in office shall be necessary and sufficient to constitute a quorum, and the act of a majority of the members of the Executive Committee present at a meeting of the Executive Committee shall be the act of the Executive Committee. The Executive Committee shall keep full and fair records and accounts of its proceedings and transactions. All actions by the Executive Committee shall be reported to the Board of Directors at its next meeting.

Section 4. Governance and Board Excellence Committee.

The Governance and Board Excellence Committee (the "Committee") shall be comprised of a chair and two to four Directors. The Chair of the Governance and Board Excellence Committee shall be the Vice-Chair of the Board. The Committee reports directly to the Board of Directors.

The Committee shall develop, and ensure appropriate implementation of the Board's goals. The Committee will offer orientations and onboarding strategies to impart Director duties, review the Friends' mission statement, and emphasize the appropriate respect of diversity, equity, and inclusion, among other subjects.

The Committee shall periodically review the defined and adopted mission and vision statements of the organization and determine whether they are consistent across documents and activities. It shall further review the governing documents of the organization and determine whether they are consistent with applicable laws and actual or desired organizational practices and

suggest amendments to such governing documents as necessary.

The Committee shall locate and recruit potential Directors and shall direct enrichment activities for the Board. The Committee shall establish Board composition priorities, meet with potential Directors to explain the work of Friends, and identify strengths of candidates for the Board of Directors. Meetings of the Committee shall be held as necessary, approximately two (2) or more times per year. The objectives of the Committee also include the following:

- o Nomination of the Officers of the Board
- Development of criteria for selection of Directors
- o Recommendations for nomination/re-nomination to Board membership
- o Development of a strategy for cultivation of new Directors
- o Development of tools for evaluation of overall Board performance
- o Development of tools for individual Director's self-assessment
- Implementation of programs to promote the effectiveness of existing and new Directors through communication, training and orientation activities
- Section 5. <u>Committees</u>. Other committees may be created to conduct the work of the Friends, either specifically to enhance the function of the Board or to work on raising additional funds for the Law Library, or for other purposes as determined by the Board and the Friends' Executive Director.
- Section 6. <u>Committee Meetings</u>. Unless otherwise provided for in these bylaws, a majority of the members serving on a committee constitutes a quorum of the committee for the meeting of the committee and the vote of a simple majority of those present at a meeting at which a quorum is present constitutes an action of the committee. Each committee shall determine and schedule the number of regular meetings it will hold each year in connection with the Executive Director or the Chair.

ARTICLE 10: OFFICERS

Secretary and Treasurer and such other officers as the Board may designate by resolution; provided that at no time shall any Board of Trustees members or Law Library officers or employees serve concurrently as officers or employees of Friends. The same person may hold any number of offices, except that neither the secretary nor the treasurer may serve concurrently as the Chair (or president, if there is a president position created). The Chair may, however, assist the secretary and treasurer with the performance of their duties. In addition to the duties specified in this Article 10, officers shall perform all other duties customarily incident to their office and such other duties as may be required by law, by the Articles of Incorporation, or by these bylaws, subject to control of the Board of Directors, and shall perform such additional duties as the Board of Directors shall from time-to-time assign.

The officers shall be chosen by the Board at its annual meeting, and shall serve at the pleasure of the Board, for a term of two (2) years which can be renewed and subject to the rights, if any, of any officer under any contract of employment. Without prejudice to any rights of an officer under any contract of employment, any officer may be removed with or without cause by the Board. Any officer may resign at any time by giving written notice to the Board of Directors, the Chair of the Board, the Executive Director, or the secretary of Friends, without prejudice, however, to the rights, if any, of Friends under any contract to which such officer is a party. Any resignation shall take effect on the date of the receipt of such notice or at any later time specified in the resignation; and, unless otherwise specified in the resignation, the acceptance of the resignation shall not be necessary to make it effective. A vacancy in any office because of death, resignation, removal, disqualification, or any other cause shall be filled in the manner prescribed in these bylaws for regular appointments to that office, except that the Board of Directors may choose a new officer to fill a vacancy as soon as possible after the vacancy occurs, and need not wait until the annual meeting. The compensation, if any, of the officers shall be fixed or determined by resolution of the Board of Directors.

- Section 2. <u>Chair of the Board</u>. The Chair of the Board (who may also be referred to as the "president" of the Board, if the Board so designates) shall, when present, preside at all meetings of the Board of Directors and Executive Committee. The Chair is authorized to execute in the name of Friends all contracts and other documents authorized either generally or specifically by the Board to be executed by Friends, except when by law the signature of the Executive Director is required.
- Section 3. <u>Vice Chair of the Board</u>. The Vice Chair (who may also be referred to as the "vice-president" of the Board, if the Board so designates) shall, in the absence of the Chair, or in the event of his or her inability or refusal to act, perform all the duties of the Chair, and when so acting shall have all the powers of, and be subject to all the restrictions on, the Chair. The Vice Chair shall also chair the Governance and Board Excellence Committee, as set forth in Article 9, Section 4.
- Executive Director. Subject to the control, advice and consent of the Section 4. Board of Directors, the Executive Director shall, in general, supervise and conduct the activities and operations of Friends, shall keep the Board of Directors fully informed and shall freely consult with them concerning the activities of Friends, and shall see that all orders and resolutions of the Board are carried into effect. Where appropriate, the Board of Directors shall place the Executive Director under a contract of employment. The Executive Director shall be empowered to act, speak for, or otherwise represent Friends between meetings of the Board. The Executive Director shall be responsible for the hiring and firing of all personnel, and shall be responsible for keeping the Board informed at all times of staff performance and for implementing any personnel policies adopted by the Board. The Executive Director is authorized to contract, receive, deposit, disburse, and account for funds of Friends; to execute in the name of Friends all contracts and other documents authorized either generally or specifically by the Board to be executed by Friends; and to negotiate all material business transactions of Friends. Unless otherwise specified by Board resolution, the Executive Director shall serve the functions of chief executive officer of Friends. Additionally, the Executive Director shall have the right to be present at all Board meetings of Friends; provided that the Executive Director shall not have the right to vote in any such meetings.

Section 5. <u>Secretary</u>. The secretary, or his or her designee, shall be custodian of all records and documents of Friends, shall act as secretary of all the meetings of the Board of Directors, and shall keep the minutes of all such meetings. The secretary, or his or her designee, also shall take minutes of all business conducted at the meetings of the Executive Committee, and be prepared, at the Chair's request, to send each Director of the Board of Directors, a summary report of the minutes of such meetings.

Section 6. <u>Treasurer</u>. The treasurer, or his or her designee, shall keep and maintain, or cause to be kept and maintained, adequate and correct accounts of the properties and business transactions of Friends, including accounts of its assets, liabilities, receipts, disbursements, gains, losses, capital, retained earnings, and other matters customarily included in financial statements.

The treasurer shall deposit or cause to be deposited all moneys and other valuables in the name and to the credit of Friends with such depositories as may be designated by the Board of Directors. The treasurer shall disburse or cause to be disbursed the funds of Friends as may be ordered by the Board of Directors, and shall render to the Chair, Executive Director, Directors, whenever they request it, an account of all of the treasurer's transactions as treasurer and of the financial condition of the Friends.

If required by the Board of Directors, the treasurer shall give Friends a bond in the amount and with the surety or sureties specified by the Board for faithful performance of the duties of the treasurer's office and for restoration to Friends of all its books, papers, vouchers, money and other property of every kind in the treasurer's possession or under the treasurer's control on the treasurer's death, resignation, retirement, or removal from office. Friends shall pay the cost of such bond.

ARTICLE 11: EXECUTION OF CORPORATE INSTRUMENTS

Section 1. <u>Execution of Corporate Instruments</u>. The Board of Directors may, in its discretion, determine the method and designate the signatory officer or officers or other person or persons, to execute any corporate instrument or document, or to sign the corporate name without limitation, except when otherwise provided by law, and such execution or signature shall be binding upon Friends.

Unless otherwise specifically determined by the Board of Directors or otherwise required by law, formal contracts of Friends, promissory notes, deeds of trust, mortgages, and other evidences of indebtedness of Friends, and other corporate instruments or documents, memberships in other corporations, and certificates of shares of stock owned by Friends, shall be executed, signed, or endorsed by the Chair of the Board, Vice Chair of the Board or the Executive Director and by the secretary or treasurer or any assistant secretary or assistant treasurer.

All checks and drafts drawn on banks or other depositories on funds to the credit of Friends, or in special accounts of Friends, shall be signed by such person or persons as the Board of Directors shall authorize to do so.

Section 2. <u>Loans and Contracts</u>. No loans or advances shall be contracted on behalf of Friends and no note or other evidence of indebtedness shall be issued in its name unless and except as the specific transaction is authorized by the Board of Directors. Without the express and specific authorization of the Board, no officer or other agent of Friends may enter into any contract or execute and deliver any instrument in the name of and on behalf of Friends.

ARTICLE 12: ARTICLE 12: RECORDS AND REPORTS

- Section 1. <u>Maintenance and Inspection of Articles and Bylaws</u>. Friends shall keep at its principal office the original or a copy of its Articles of Incorporation and bylaws as amended to date, which shall be open to inspection by the Directors at all reasonable times during office hours.
- Section 2. <u>Maintenance and Inspection of Federal Tax Exemption Application and Annual Information Returns</u>. Friends shall keep at its principal office a copy of its federal tax exemption application and its annual information returns for three years from their date of filing, which shall be open to public inspection and copying to the extent required by law.
- Section 3. Maintenance and Inspection of Other Corporate Records. Friends shall keep adequate and correct books and records of accounts, and written minutes of the proceedings of the Board and committees of the Board. All such records shall be kept at such place or places designated by the Board of Directors, or, in the absence of such designation, at the principal office of Friends. The minutes shall be kept in written or typed form, and other books and records shall be kept either in written or typed form or in any other form capable of being converted into written, typed, or printed form. Upon leaving office, each officer, employee, or agent of the corporation shall turn over to his or her successor or the Chair or Executive Director, in good order, such corporate monies, books, records, minutes, lists, documents, contracts or other property of Friends as have been in the custody of such officer, employee, or agent during his or her term of office.

Every Director shall have the absolute right at any reasonable time to inspect all books, records, and documents of every kind and the physical properties of Friends and each of its subsidiary corporations. The inspection may be made in person or by an agent or attorney, and shall include the right to copy and make extracts of documents.

- Section 4. <u>Annual Report; Statement of Certain Transactions</u>. The Board shall cause an annual report to be sent to all Directors of Friends within 120 days after the end of the corporation's fiscal year containing the following information:
- (a) The assets and liabilities, including the trust funds, of Friends at the end of the fiscal year;
- (b) The principal changes in assets and liabilities, including trust funds, during the fiscal year;
- (c) The revenues or receipts of Friends, both unrestricted and restricted for particular purposes, for the fiscal year;

- (d) The expenses or disbursements of Friends for both general and restricted purposes during the fiscal year; and
- (e) The information required by Section 6322 of the Law concerning certain self-dealing transactions involving more than \$50,000 or indemnifications involving more than \$10,000 which took place during the fiscal year.

The report shall be accompanied by any pertinent report of independent accountants, or, if there is no such report, the certificate of an authorized officer of Friends that such statements were prepared without audit from the books and records of Friends.

ARTICLE 13: FISCAL YEAR

The fiscal year for Friends shall begin on July 1 and shall end on June 30th.

ARTICLE 14: AMENDMENTS AND REVISIONS

These bylaws may be adopted, amended or repealed by the vote of a majority of the Directors then in office. Such action is authorized only at a duly called and held meeting of the Board of Directors for which written notice of such meeting, setting forth the proposed bylaw revisions with explanations therefore, is given in accordance with these bylaws, unless such notice is waived in accordance with these bylaws. If any provision of these bylaws requires the vote of a larger proportion of the Board than is otherwise required by law, that provision may not be altered, amended, or repealed except by that greater vote. Any adoption, amendment or repeal of these bylaws that adversely affects the rights granted to the Board of Trustees or the existing Directors of Friends under the bylaws, including without limitation the right to appoint Directors, to fill vacancies on the Board of Directors, and the rights granted by this Article 14, shall also require the approval of the Board of Trustees.

ARTICLE 15: CORPORATE SEAL

The Board of Directors may adopt, use, and alter a corporate seal. The seal shall be kept at the principal office of Friends. Failure to affix the seal to any corporate instrument, however, shall not affect the validity of that instrument.

ARTICLE 16: CONSTRUCTION AND DEFINITIONS

Unless the context otherwise requires, the general provisions, rules of construction, and definitions contained in the California Nonprofit Corporation Law as amended from time to time shall govern the construction of these bylaws. Without limiting the generality of the foregoing, the masculine gender includes the feminine and neuter, the singular number includes the plural and the plural number includes the singular, and the term "person" includes a corporation as well as a natural person. If any competent court of law shall deem any portion of these bylaws invalid or inoperative, then so far as is reasonable and possible (1) the remainder of these bylaws shall be considered valid and operative, and (2) effect shall be given to the intent manifested by the portion deemed invalid or inoperative.

AMENDED AND RESTATED BYLAWS

OF

FRIENDS OF THE LOS ANGELES COUNTY LAW LIBRARY (a California Nonprofit Public Benefit Corporation)

ARTICLE 1: NAME

The name of this corporation is Friends of the Los Angeles County Law Library.

ARTICLE 2: PURPOSES

This corporation has been formed for charitable purposes. The creation of this corporation is not intended to supersede state policy regarding funding of county law libraries as provided under California Business and Professions Code Section 6300 et al., (or any successor section to that code, if applicable). This corporation has been formed to raise funds (generally from the private sector) to support the collections, staff, facilities, and programs and services of the Los Angeles County Law Library ("Law Library"); AH funds raised by the corporation, except those retained for the corporation's reasonable administrative and operating expenses, shall be directed towards the Law Library in furtherance of the corporation's purpose to support the activities of the Law Library. In addition, this corporation is formed for the purposes of performing all things incidental to, or appropriate in, the achievement of the foregoing specific and primary purposes. However, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of its primary charitable purposes.

This corporation shall hold and may exercise all such powers as may be conferred upon a nonprofit corporation by the laws of the State of California and as may be necessary or expedient for the administration of the affairs and attainment of the purposes of the corporation, <u>provided</u>, <u>however</u>, that in no event shall the corporation engage in activities which are not permitted to be carried on by a corporation exempt under Section 501(c)(3) of the Internal Revenue Code. Additionally, the corporation's activities shall be limited in the following ways:

- 1. The corporation shall act as a separate corporation in a fundraising capacity to the Board of Trustees.
- 2. The corporation is not the agent of the Law Library or of the Law Library Board of Trustees (the "Board of Trustees") and shall have no right or authority to bind or contract for the Law Library or the Board of Trustees. The corporation's

support of the Law Library shall not in any way enable it to control the policies, programs or services offered by the Law Library.

ARTICLE 3: PRINCIPAL OFFICE

The initial principal office of the corporation shall be located in the City of Los Angeles, County of Los Angeles, State of California. The Board of Directors may at any time, or from time to time, change the location of the principal office from one location to another within said city and county.

The Board of Directors may at any time establish branch offices at any place where the corporation is qualified to do business.

ARTICLE 4: NONPARTISAN ACTIVITIES

This corporation has been formed under California Nonprofit Public Benefit Corporation Law, Sections 5110-6910 and any successor sections, as applicable (the "Law") for the charitable purposes described above, and it shall be nonprofit and nonpartisan. No substantial part of the activities of the corporation shall consist of the publication or dissemination of materials with the purpose of attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE 5: DEDICATION OF ASSETS

The properties and assets of this nonprofit corporation are irrevocably dedicated to charitable purposes. No part of the net earnings, properties, or assets of this corporation, on dissolution or otherwise, shall inure to the benefit of any private person or individual, or any member, director or officer of this corporation. On liquidation or dissolution, all remaining properties and assets of the corporation shall be distributed and paid over to another organization dedicated to charitable purposes that has established its tax-exempt status under Internal Revenue Code Section 501(c)(3).

ARTICLE 6: MEMBERSHIP

The corporation shall not have any members within the meaning of Section 5056 of the California Corporations Code. Nothing contained in this Article 6 shall be construed to limit the right of the corporation to refer to persons associated with the corporation as "members" even though such persons are not members, and no such reference shall constitute anyone being a member, within the meaning of Section 5056 of the California Corporations Code. Upon designation of criteria for advisory membership by the Board of Directors, the corporation may have advisory members who are not members within the meaning of Section 5056 of the California Corporations Code.

ARTICLE 7: BOARD OF DIRECTORS

Section 1. <u>Powers</u>. Subject to the provisions and limitations of the Law and any other applicable laws, the business and affairs of the corporation shall be managed, and all corporate powers shall be exercised, by or under the direction of the Board of Directors. The Board of Directors may delegate the management of the day-to-day operation of the business of the corporation to a management company, committee (however composed), or other person, provided that the activities and affairs of the corporation shall be managed and all corporate powers shall be exercised under the ultimate direction of the Board of Directors.

Section 2. <u>Number of Directors</u>. Initially, a three (3) member Board of Directors shall govern this corporation. As of the date of the first annual meeting of the directors, the authorized number of directors shall consist of not less than 9 (nine) positions nor more than 25 (twenty-five) positions, the exact number of Directors to be fixed, within the limits specified in this Section 7.2, by resolution of the Board.

Section 3. <u>Designation and Term of Office of Directors</u>. The initial Board of Directors shall serve until their successors have been appointed and seated at the first annual meeting of the directors. After the first annual meeting of the directors, the Board of Trustees shall appoint a majority of directors of this corporation; provided, that at no time shall any Board of Trustees members or Law Library officers or employees serve concurrently on the board of this corporation. The remaining directors of this corporation shall be self-perpetuating and appointed by the existing directors of this corporation as vacancies occur.

The term of office of each director shall be two (2) years. At the first annual meeting, the directors shall be divided into two (2) groups (one group will be those directors who have been appointed by the Board of Trustees (the "Board of Trustees group" and the other group will be the remaining self-perpetuating directors (the "Self-Perpetuating group"). The Self-Perpetuating group shall initially serve two (2) year terms, and the Board of Trustees group shall initially serve a one (1) year term. Thereafter, the term of office of each director shall be two (2) years. If any annual meeting is not held or the Board of Trustees group or the Self-Perpetuating group is not appointed at the annual meeting, members of the Board of Trustees group or the Self-Perpetuating group may be appointed by the Board of Trustees or the existing directors, as the case may be, at any time thereafter.

Except as otherwise provided in these Bylaws, each director, including a director appointed to fill a vacancy, shall hold office until expiration of the term for which appointed and until a successor has been appointed and qualified. Directors may serve any number of consecutive terms.

The Board of this corporation shall act towards the Board of Trustees in a fundraising capacity only. The Board shall not act as an agent of the Law Library or of the Board of Trustees and shall have no right or authority to bind or contract for the Law Library or the Board of Trustees.

Section 3.1. Board Composition

This corporation's Board members shall collectively represent a diversity of relevant backgrounds and include members of the legal and business communities at-large and/or have demonstrated commitment to the Law Library either as patrons, funders or supporters thereof.

Section 4. <u>Vacancies</u>. A vacancy on the board shall exist on the occurrence of the following: (a) the death, resignation, or removal of any director; (b) the declaration by resolution of the board of a vacancy in the office of a director who has been declared of unsound mind by a final order of court, convicted of a felony, or found by final order or judgment of any court to have breached a duty under Sections 5230-5239 of the Law dealing with standards of conduct for a director, or has missed three (3) consecutive meetings of the Board of Directors or a total of four (4) meetings of the board during any one calendar year; (c) an increase in the authorized number of directors; or (d) the failure of the Board of Trustees or the Friends of the Los Angeles County Law Library, at any annual meeting or otherwise, to appoint the full authorized number of directors.

The Board of Directors, by affirmative vote of a majority of the directors then in office, may remove any director with or without cause at any regular or special meeting; provided that the director to be removed and the Board of Trustees have been notified in writing in the manner set forth in Article 7, Section 5 that such action would be considered at the meeting.

Except as provided in this paragraph, any director may resign effective upon giving written notice to the chairperson of the board, the executive director, the secretary, or the Board of Directors, unless the notice specifies a later time for the effectiveness of the resignation. If the resignation is effective at a future time, a successor may be designated to take office when the resignation becomes effective. Unless the California Attorney General is first notified, no director may resign when the corporation would then be left without a duly elected director in charge of its affairs. All vacancies on the board shall be filled by the Board of Trustees or the existing directors of the corporation, as the case may be and depending on whether the vacancy arose from a slot previously appointed by the Board of Trustees or the existing directors of the corporation. In the event that the Board of Trustees does not fill vacancies to which it is entitled within a reasonable period of time, the existing directors shall adopt a temporary board resolution (lasting for not more than 90 days) resetting the authorized number of board members so that the actual number of board members constitutes the authorized number. If at the end of such period the Board of Trustees has not acted, then the remaining board members shall make the determination whether to change the authorized number of board members or to fill such vacancies themselves. No reduction of the authorized number of directors shall have the effect of removing any director before that director's term of office expires.

Section 5. <u>Meetings</u>. The Board of Directors shall hold an annual meeting on the third Wednesday of September of each year for the purpose of seating directors,

electing officers of the corporation and for the transaction of other business. Notice of the annual meeting shall be given in the manner set forth below. Other regular meetings shall be held at such times as are fixed by the Board of Directors. Such regular meetings may be held without notice. Meetings may be held at any place designated by the chairperson of the board, or, if not designated, at the principal office of the corporation. Special meetings shall be held at any place designated in the notice of the meeting or, if not stated in the notice or if there is no notice, at the principal office of the corporation. Notwithstanding the above, any meeting may be held at any place consented to in writing (including via e-mail) by all the directors, either before or after the meeting. Consents shall be filed with the minutes of the meeting.

Any meeting may be held by conference telephone or other communications equipment permitted by the Law, as long as all directors participating in the meeting can communicate with one another and all other requirements of the Law are satisfied. All such directors shall be deemed to be present in person at such meeting.

Meetings of the board for any purpose may be called at any time by the chairperson of the board, the executive director, the secretary, or any two (2) directors. Notice of the date, time, and place of meetings shall be delivered personally to each director or communicated to each director by telephone (including a voice messaging system which records and communicates messages), facsimile, or electronic mail at least forty-eight (48) hours prior to the meeting, or communicated by telegraph, express mail service, first-class mail, or by other means of written communication, charges prepaid, addressed to the director at the director's address as it is shown upon the records of the corporation, deposited in the mails or given to the telegraph company or express mail company or other carrier at least four (4) days before the date of the meeting. The notice need not specify the purpose of the meeting. Notice of a meeting need not be given to any director who signs a waiver of notice or a consent to holding the meeting or an approval of the minutes of the meeting, whether before or after the meeting, or who attends the meeting without protesting, prior to the meeting or at its commencement, the lack of notice to such director. The waiver of notice or consent need not specify the purpose of the meeting. All such waivers, consents, and approvals shall be filed with the corporate records or made a part of the minutes of the meeting.

Section 6. Action at a Meeting. Presence of a majority of the directors then in office or of the authorized number of directors at a meeting of the Board of Directors constitutes a quorum for the transaction of business, except as otherwise provided in these Bylaws. The presence of five (5) directors at a meeting of the Board of Directors constitutes a quorum for the transaction of business, except as otherwise provided in these Bylaws. Every act done or decision made by a majority of the directors present at a meeting duly held at which a quorum is present shall be regarded as the act of the Board of Directors, unless a greater number, or the same number after disqualifying one or more directors from voting, is required by the Articles of Incorporation, these bylaws, or the Law. Directors may not vote by proxy. A meeting at which a quorum is initially present, including an adjourned meeting, may continue to transact business notwithstanding the withdrawal of directors, if any action taken is approved by at least a

disinterested majority of the required quorum for such meeting, or such greater number as required by the Articles of Incorporation, these bylaws or the Law.

Section 7. <u>Adjourned Meeting and Notice</u>. A majority of the directors present, whether or not a quorum is present, may adjourn any meeting to another time and place. If the meeting is adjourned for more than twenty-four (24) hours, notice of any adjournment to another time or place shall be given prior to the time of the adjourned meeting to the directors who were not present at the time of the adjournment. Such notice may be waived in the manner provided for in Article 7, Section 5.

Section 8. Action Without a Meeting. The Board of Directors may take any required or permitted action without a meeting, if all members of the board shall individually or collectively consent in writing to such action. Such written consent or consents shall be filed with the minutes of the proceedings of the board. Such action by written consent shall have the same force and effect as the unanimous vote of such directors. For purposes of this section only, "all members of the board" does not include any "interested directors" as defined in Section 5233 of the Law.

Section 9. <u>Fees and Compensation</u>. Directors and members of committees may not receive any compensation for their services as such, but may receive reasonable reimbursement of expenses incurred in the performance of their duties, including advances as provided in Article 8, Section 2, as may be fixed or determined by resolution of the Board of Directors. Directors may not be compensated for rendering services to this corporation in any capacity other than director, unless such compensation is reasonable and (a) approved as provided in Article 8, Section 4, and (b) allowable under Article 8, Section 6.

ARTICLE 8: STANDARD OF CARE

Section 1. <u>General</u>. A director shall perform the duties of a director, including duties as a member of any committee of the board on which the director may serve, in good faith, in a manner such director believes to be in the best interest of this corporation and with such care, including reasonable inquiry, as an ordinarily prudent person in a like situation would use under similar circumstances.

In performing the duties of a director, a director shall be entitled to rely on information, opinions, reports or statements, including financial statements and other financial data, in each case prepared or presented by:

- (a) one or more officers or employees of the corporation whom the director believes to be reliable and competent in the matters presented,
- (b) counsel, independent accountants or other persons as to matters which the director believes to be within such person's professional or expert competence, or
- (c) a committee of the board upon which the director does not serve, as to matters within its designated authority, which committee the director believes to merit confidence,

so long as in any such case, the director acts in good faith, after reasonable inquiry when the need therefore is indicated by the circumstances and without knowledge that would cause such reliance to be unwarranted.

Except as provided in Article 8, Section 3, a person who performs the duties of a director in accordance with the above shall have no liability based upon any failure or alleged failure to discharge that person's obligations as a director, including, without limiting the generality of the foregoing, any actions or omissions which exceed or defeat a public or charitable purpose to which the corporation, or assets held by it, are dedicated.

Section 2. <u>Loans</u>. This corporation shall not make any loan of money or property to, or guarantee the obligation of, any director or officer, unless approved by the California Attorney General; provided, however, that this corporation may advance money to a director or officer of this corporation or any subsidiary for expenses reasonably anticipated to be incurred in performance of the duties of such officer or director so long as such individual would be entitled to be reimbursed for such expenses absent that advance.

Section 3. <u>Self-Dealing Transactions</u>. Except as approved in Section 4 below, the board shall not approve a self-dealing transaction. A self-dealing transaction is one to which the corporation is a party and in which one or more of the directors has a material financial interest or a transaction between this corporation and any person (other than a California nonprofit public benefit corporation) in which one or more of the directors is a director or between this corporation and any person in which one or more of its directors has a material financial interest. A director shall not be deemed to have a "material financial interest" in a contract or transaction that implements a charitable program of this corporation solely because the contract or transaction results in a benefit to a director or his or her family by virtue of their membership in the class of persons intended to be benefited by the charitable program, as long as the contract or transaction is approved or authorized by the corporation in good faith and without unjustified favoritism.

Section 4. <u>Approval</u>. The Board of Directors may approve a self-dealing transaction if the board determines that the transaction is in the best interests of, and is fair and reasonable to, this corporation and, after reasonable investigation under the circumstances, determines that this corporation could not have obtained a more advantageous arrangement with reasonable effort under the circumstances. Such determinations must be made by the board, in good faith, with knowledge of the material facts concerning the transaction and the director's interest in the transaction, and by a vote of the majority of the directors then in office, provided that a quorum is present, without counting the vote of the interested director or directors.

Section 5. <u>Mutual Directors</u>. No contract or other transaction between the corporation and any California nonprofit public benefit corporation of which one or more of its directors are directors of this corporation is either void or voidable because such directors) are present at a meeting of the board which authorizes, approves, or ratifies

the contract or transaction if the material facts as to the transaction and as to such director's other directorship are fully disclosed or known to the board and the board authorizes, approves, or ratifies the contract or transaction in good faith by a vote sufficient without counting the vote of the common director(s), or if the contract or transaction is just and reasonable as to the corporation at the time it is authorized, approved or ratified.

Section 6. Restriction on Interested Directors. Not more than forty-nine percent (49%) of the persons serving on the Board of Directors at any time may be interested persons. An interested person is (1) any person currently being compensated by the corporation for services rendered to it within the previous twelve (12) months, whether as a full-time or part-time employee, independent contractor, or otherwise, excluding any reasonable compensation paid to a director as director; and (2) any brother, sister, ancestor, descendant, spouse, brother-in-law, sister-in-law, son-in-law, daughter-in-law, mother-in-law, or father-in-law of any such person. However, any violation of the provisions of this section shall not affect the validity or enforceability of any transaction entered into by the corporation.

Section 7. Indemnification. To the fullest extent permitted by law, this corporation shall indemnify its "agents", as described in Section 5238(a) of the Law, including its directors, officers, employees, and volunteers, and including persons formerly occupying any such position, and their heirs, executors, and administrators, against all expenses, judgments, fines, settlements, and other amounts actually and reasonably incurred by them in connection with any "proceeding, " as that term is used in said Section 5238(a), and including an action by or in the right of the corporation, by reason of the fact that the person is or was a person described in that Section. "Expenses" shall have the same meaning as in said Section. Such right of indemnification shall not be deemed exclusive of any other rights to which such persons may be entitled apart from this Article 8, Section 7.

To the fullest extent permitted by law and except as otherwise determined by the board in a specific instance, expenses incurred by a person seeking indemnification in defending any "proceeding" shall be advanced by the corporation before final disposition of the proceeding upon receipt by the corporation of an undertaking by or on behalf of that person to repay such amount unless it is ultimately determined that the person is entitled to be indemnified by the corporation for those expenses.

The corporation shall have power to purchase and maintain insurance to the fullest extent permitted by law on behalf of any agent of the corporation, against any liability asserted against or incurred by the agent in such capacity or arising out of the agent's status as such, or to give other indemnification to the extent permitted by law.

ARTICLE 9: COMMITTEES

Section 1. <u>Committees of Directors</u>. The Board of Directors may, by resolution adopted by a majority of the directors then in office, provided that a quorum is present, designate one or more committees to exercise all or a portion of the authority

of the board, to the extent of the powers specifically delegated in the resolution of the board or in these bylaws. Each such committee shall consist of two (2) or more directors, and may also include persons who are not on the board, to serve at the pleasure of the board. The board may designate one or more alternate members of any committee, who may replace any absent member at any meeting of the committee. The appointment of members or alternate members of a committee requires the vote of a majority of the directors then in office, provided that a quorum is present. The Board of Directors may also designate one or more advisory committees that do not have the authority of the board. However, no committee, regardless of board resolution, may:

- (a) Approve any action that, under the Law, would also require the affirmative vote of the members if this were a membership corporation.
- (b) Fill vacancies on, or remove the members of, the Board of Directors or in any committee that has the authority of the board.
- (c) Fix compensation of the directors for serving on the board or on any committee.
- (d) Amend or repeal the Articles of Incorporation or bylaws or adopt new bylaws.
- (e) Amend or repeal any resolution of the Board of Directors that by its express terms is not so amendable or repealable.
 - (f) Appoint any other committees of the Board of Directors or their members.
- (g) Approve a plan of merger; consolidation; voluntary dissolution; bankruptcy or reorganization; or for the sale, lease, or exchange of all or substantially all of the property and assets of the corporation otherwise than in the usual and regular course of its business; or revoke any such plan.
- (h) Approve any self-dealing transaction, except as provided by Section 5233 of the Law.

No committee shall bind the corporation in a contract or agreement or expend corporate funds, unless authorized to do so by the Board of Directors.

Section 2. Meetings and Actions of Committees. Meetings and actions of all committees shall be governed by, and held and taken in accordance with, the provisions of Article 7 of these bylaws, concerning meetings and actions of directors, with such changes in the context of those bylaws as are necessary to substitute the committee and its members for the Board of Directors and its members, except that the time for regular meetings of committees may be determined either by resolution of the Board of Directors or by resolution of the committee. Special meetings of committees may also be called by resolution of the Board of Directors. Notice of special meetings of committees shall also be given to any and all alternate members, who shall have the right to attend all meetings of the committee. Minutes shall be kept of each meeting of

any committee and shall be filed with the corporate records. The Board of Directors may adopt rules not inconsistent with the provisions of these bylaws for the government of any committee.

Section 3. <u>Executive Committee</u>. Pursuant to Article 9, Section 1, the board may appoint an Executive Committee composed of three (3) or more directors, one of whom shall be the chairperson of the board, to serve as the Executive Committee of the board. The Executive Committee, unless limited in a resolution of the board, shall have and may exercise all the authority of the board in the management of the business and affairs of the corporation between meetings of the board; provided, however, that the Executive Committee shall not have the authority of the board in reference to those matters enumerated in Article 9, Section 1. The secretary of the corporation shall send to each director a summary report of the business conducted at any meeting of the Executive Committee.

ARTICLE 10: OFFICERS

Section 1. Officers. The officers of the corporation shall consist of an executive director, secretary and treasurer and such other officers as the board may designate by resolution; provided, that at no time shall any Board of Trustees members or Law Library officers or employees serve concurrently as officers or employees of this corporation. The same person may hold any number of offices, except that neither the secretary nor the treasurer may serve concurrently as the executive director or chairperson (or president, if there is a president position created). The Executive Director may, however, assist the Secretary and Treasurer with the performance of their duties. In addition to the duties specified in this Article 10, officers shall perform all other duties customarily incident to their office and such other duties as may be required by law, by the Articles of Incorporation, or by these bylaws, subject to control of the Board of Directors, and shall perform such additional duties as the Board of Directors shall from time to time assign.

The officers shall be chosen by the board at its annual meeting, and shall serve at the pleasure of the board, subject to the rights, if any, of any officer under any contract of employment. Without prejudice to any rights of an officer under any contract of employment, any officer may be removed with or without cause by the board. Any officer may resign at any time by giving written notice to the Board of Directors, the chairperson of the board, the executive director, or the secretary of the corporation, without prejudice, however, to the rights, if any, of the corporation under any contract to which such officer is a party. Any resignation shall take effect on the date of the receipt of such notice or at any later time specified in the resignation; and, unless otherwise specified in the resignation, the acceptance of the resignation shall not be necessary to make it effective. A vacancy in any office because of death, resignation, removal, disqualification, or any other cause shall be filled in the manner prescribed in these bylaws for regular appointments to that office, except that the Board of Directors may choose a new officer to fill a vacancy as soon as possible after the vacancy occurs, and need not wait until the annual meeting. The compensation, if any, of the officers shall be fixed or determined by resolution of the Board of Directors.

Section 2. <u>Chairperson of the Board</u>. The chairperson of the board (who may also be referred to as the president of the board, if the board so designates) shall, when present, preside at all meetings of the Board of Directors and Executive Committee. The chairperson is authorized to execute in the name of the corporation all contracts and other documents authorized either generally or specifically by the board to be executed by the corporation, except when by law the signature of the executive director is required.

Section 3. <u>Vice Chairperson of the Board</u>. The vice chairperson (who may also be referred to as the vice-president of the board, if the board so designates) shall, in the absence of the chairperson, or in the event of his or her inability or refusal to act, perform all the duties of the chairperson, and when so acting shall have all the powers of, and be subject to all the restrictions on, the chairperson.

Executive Director. Subject to the control, advice and consent of Section 4. the Board of Directors, the Executive Director shall, in general, supervise and conduct the activities and operations of the corporation, shall keep the Board of Directors fully informed and shall freely consult with them concerning the activities of the corporation, and shall see that all orders and resolutions of the board are carried into effect. Where appropriate, the Board of Directors shall place the Executive Director under a contract of employment. The Executive Director shall be empowered to act, speak for, or otherwise represent the corporation between meetings of the board. The Executive Director shall be responsible for the hiring and firing of all personnel, and shall be responsible for keeping the board informed at all times of staff performance and for implementing any personnel policies adopted by the board. The Executive Director is authorized to contract, receive, deposit, disburse, and account for funds of the corporation; to execute in the name of the corporation all contracts and other documents authorized either generally or specifically by the board to be executed by the corporation; and to negotiate all material business transactions of the corporation. Unless otherwise specified by board resolution, the Executive Director shall serve the functions of chief executive officer of the corporation. Additionally, the Executive Director shall have the right to be present at all board meetings of this corporation; provided, that the Executive Director shall not have the right to vote in any such meetings.

Section 5. <u>Secretary</u>. The secretary, or his or her designee, shall be custodian of all records and documents of the corporation which are to be kept at the principal office of the corporation, shall act as secretary of all the meetings of the Board of Directors, and shall keep the minutes of all such meetings in books proposed for that purpose. He or she shall attend to the giving and serving of all notices of the corporation, and shall see that the seal of the corporation is affixed to all documents, the execution of which on behalf of the corporation under its seal is duly authorized in accordance with the provisions of these bylaws.

Section 6. <u>Treasurer</u>. The treasurer, or his or her designee, shall keep and maintain, or cause to be kept and maintained, adequate and correct accounts of the properties and business transactions of the corporation, including accounts of its assets,

liabilities, receipts, disbursements, gains, losses, capital, retained earnings, and other matters customarily included in financial statements.

The treasurer shall deposit or cause to be deposited all moneys and other valuables in the name and to the credit of the corporation with such depositories as may be designated by the Board of Directors. The treasurer shall disburse or cause to be disbursed the funds of the corporation as may be ordered by the Board of Directors, and shall render to the chairperson, executive director, directors, whenever they request it, an account of all of the treasurer's transactions as treasurer and of the financial condition of the corporation.

If required by the Board of Directors, the treasurer shall give the corporation a bond in the amount and with the surety or sureties specified by the board for faithful performance of the duties of the treasurer's office and for restoration to the corporation of all its books, papers, vouchers, money and other property of every kind in the treasurer's possession or under the treasurer's control on the treasurer's death, resignation, retirement, or removal from office. The corporation shall pay the cost of such bond.

ARTICLE 11: EXECUTION OF CORPORATE INSTRUMENTS

Section 1. <u>Execution of Corporate Instruments</u>. The Board of Directors may, in its discretion, determine the method and designate the signatory officer or officers or other person or persons, to execute any corporate instrument or document, or to sign the corporate name without limitation, except when otherwise provided by law, and such execution or signature shall be binding upon the corporation.

Unless otherwise specifically determined by the Board of Directors or otherwise required by law, formal contracts of the corporation, promissory notes, deeds of trust, mortgages, and other evidences of indebtedness of the corporation, and other corporate instruments or documents, memberships in other corporations, and certificates of shares of stock owned by the corporation, shall be executed, signed, or endorsed by the chairperson of the board, vice chairperson of the board or the executive director and by the secretary or treasurer or any assistant secretary or assistant treasurer.

All checks and drafts drawn on banks or other depositories on funds to the credit of the corporation, or in special accounts of the corporation, shall be signed by such person or persons as the Board of Directors shall authorize to do so.

Section 2. <u>Loans and Contracts</u>. No loans or advances shall be contracted on behalf of the corporation and no note or other evidence of indebtedness shall be issued in its name unless and except as the specific transaction is authorized by the Board of Directors. Without the express and specific authorization of the board, no officer or other agent of the corporation may enter into any contract or execute and deliver any instrument in the name of and on behalf of the corporation.

ARTICLE 12: ARTICLE 12: RECORDS AND REPORTS

- Section 1. <u>Maintenance and Inspection of Articles and Bylaws</u>. The corporation shall keep at its principal office the original or a copy of its Articles of Incorporation and bylaws as amended to date, which shall be open to inspection by the directors at all reasonable times during office hours.
- Section 2. <u>Maintenance and Inspection of Federal Tax Exemption Application and Annual Information Returns</u>. The corporation shall keep at its principal office a copy of its federal tax exemption application and its annual information returns for three years from their date of filing, which shall be open to public inspection and copying to the extent required by law.
- Section 3. Maintenance and Inspection of Other Corporate Records. The corporation shall keep adequate and correct books and records of accounts, and written minutes of the proceedings of the board and committees of the board. All such records shall be kept at such place or places designated by the Board of Directors, or, in the absence of such designation, at the principal office of the corporation. The minutes shall be kept in written or typed form, and other books and records shall be kept either in written or typed form or in any other form capable of being converted into written, typed, or printed form. Upon leaving office, each officer, employee, or agent of the corporation shall turn over to his or her successor or the chairperson or executive director, in good order, such corporate monies, books, records, minutes, lists, documents, contracts or other property of the corporation as have been in the custody of such officer, employee, or agent during his or her term of office.

Every director shall have the absolute right at any reasonable time to inspect all books, records, and documents of every kind and the physical properties of the corporation and each of its subsidiary corporations. The inspection may be made in person or by an agent or attorney, and shall include the right to copy and make extracts of documents.

- Section 4. <u>Annual Report; Statement of Certain Transactions</u>. The board shall cause an annual report to be sent to all directors of the corporation within 120 days after the end of the corporation's fiscal year containing the following information:
- (a) The assets and liabilities, including the trust funds, of this corporation at the end of the fiscal year;
- (b) The principal changes in assets and liabilities, including trust funds, during the fiscal year;
- (c) The revenues or receipts of this corporation, both unrestricted and restricted for particular purposes, for the fiscal year;
- (d) The expenses or disbursements of this corporation for both general and restricted purposes during the fiscal year; and

(e) The information required by Section 6322 of the Law concerning certain self-dealing transactions involving more than \$50,000 or indemnifications involving more than \$10,000 which took place during the fiscal year.

The report shall be accompanied by any pertinent report of independent accountants, or, if there is no such report, the certificate of an authorized officer of the corporation that such statements were prepared without audit from the books and records of the corporation.

ARTICLE 13: FISCAL YEAR

The fiscal year for this corporation shall begin on April 1 and shall end on March 31st.

ARTICLE 14: AMENDMENTS AND REVISIONS

These bylaws may be adopted, amended or repealed by the vote of a majority of the directors then in office. Such action is authorized only at a duly called and held meeting of the Board of Directors for which written notice of such meeting, setting forth the proposed bylaw revisions with explanations therefore, is given in accordance with these bylaws, unless such notice is waived in accordance with these bylaws. If any provision of these bylaws requires the vote of a larger proportion of the board than is otherwise required by law, that provision may not be altered, amended, or repealed except by that greater vote. Any adoption, amendment or repeal of these bylaws that adversely affects the rights granted to the Board of Trustees or the existing directors of the corporation under the bylaws, including without limitation the right to appoint directors, to fill vacancies on the Board of Directors, and the rights granted by this Article 14, shall also require the approval of the Board of Trustees.

ARTICLE 15: CORPORATE SEAL

The Board of Directors may adopt, use, and alter a corporate seal. The seal shall be kept at the principal office of the corporation. Failure to affix the seal to any corporate instrument, however, shall not affect the validity of that instrument.

ARTICLE 16: CONSTRUCTION AND DEFINITIONS

Unless the context otherwise requires, the general provisions, rules of construction, and definitions contained in the California Nonprofit Corporation Law as amended from time to time shall govern the construction of these bylaws. Without limiting the generality of the foregoing, the masculine gender includes the feminine and neuter, the singular number includes the plural and the plural number includes the singular, and the term "person" includes a corporation as well as a natural person. If any competent court of law shall deem any portion of these bylaws invalid or inoperative, then so far as is reasonable and possible (i)the remainder of these bylaws shall be considered valid and operative, and (ii) effect shall be given to the intent manifested by the portion deemed invalid or inoperative.

Norman Rockwell Collotype Print from Hon. Arthur and Gloria

Gold

INTRODUCTION AND SUMMARY

The Law Library received the enclosed generous offer from Judge Arnold H. Gold and his wife Gloria V. Gold, to donating the original Norman Rockwell collotype artwork currently on loan and display at the Law Library. The Board is asked to authorize execution of the attached agreement accepting the work and agreeing to certain modest conditions.

BACKGROUND AND ANALYSIS

In 2015, Judge and Mrs. Gold loaned the limited edition signed print of the iconic Norman Rockwell painting, "The Problem We All Live With" to the Law Library. The print is both artistically and legally significant. The painting depicts 6-year-old Ruby Bridges' history-changing walk integrating the William Frantz Public School in New Orleans on November 14, 1960. The print reflects the racial tensions surrounding the desegregation of public schools in the south after the landmark 1954 Supreme Court ruling in *Brown v Board of Education*, ending segregation, not only in public schools, but throughout a wide variety of public venues. The original painting has been exhibited in many significant and prestigious locations throughout the country, including outside the Oval Office at the specific request of President Barack Obama. Norman Rockwell Museum Director/CEO Laurie Norton Moffatt explained, "The painting has come to serve as an important symbol of civil rights, and Museum Trustee Ruby Bridges' historic journey."

The collotype has been on display at the Law Library continuously since its unveiling in 2015. It has not only added to the aesthetics of the public space, it has prompted questions and comments, and served as an educational prompt for discussions about civil rights and segregation.

At this time, Judge and Mrs. Gold have generously offered to donate the signed, collotype print to the Law Library on condition that:



- 1. There will be no sale of the print within the first 10 years
- 2. A small plate may be placed on the frame acknowledging the donors; and
- 3. If there is a period of more than 45 days in the first 10 years when the print is not on display, then ownership will revert to the donors' granddaughters.

The details are in the attached agreement.

Staff is most appreciative of this offer and strongly recommends accepting the donation.
